RESOLUTION

1 WHEREAS, The passing of former Congressman John A. Young, on 2 January 22, 2002, at the age of 85, brought a great loss to the 3 family and friends of this notable Texan; and

WHEREAS, A native of Corpus Christi, Mr. Young served as U.S. Representative for Nueces and surrounding counties from 1956 to 1979 and was an active supporter of the Port of Corpus Christi throughout his tenure; during the 1960s, he led an initiative to bring an international airport to the city, and he fought tirelessly to maintain funding for the Naval Air Station in Corpus Christi; and

11 WHEREAS, Mr. Young was a key supporter of the Kennedy and 12 Johnson administrations; he served with integrity on the House 13 Rules Committee, House Merchant Marine & Fisheries Committee, and 14 House Post Office and Civil Service Committee, always keeping the 15 best interests of his constituents and his country foremost in his 16 mind; and

WHEREAS, In a sad footnote, Mr. Young rode in President Kennedy's motorcade on the day of the president's assassination; after leaving office, Mr. Young practiced law in Washington, D.C., and Corpus Christi and worked as a political consultant; and

21 WHEREAS, When he was a young man, Mr. Young graduated from St. 22 Edwards University and The University of Texas School of Law, 23 entering the Texas State Bar Association in 1940; his legal 24 ambitions were put on hold while he answered his country's call to

duty as a member of the U.S. Navy during World War II; after retiring as a lieutenant commander, he returned to Texas and served as an assistant district attorney, Nueces County attorney, and Nueces County judge; and

5 WHEREAS, Mr. Young is remembered as a distinguished Texan 6 whose 22-year record of congressional service made his district, 7 state, and nation a better place in which to live and work; his 8 numerous contributions have ensured that his spirit will live on in 9 the hearts of the many people whose lives he touched; now, 10 therefore, be it

11 RESOLVED, That the House of Representatives of the 78th Texas 12 Legislature hereby pay tribute to the life of John A. Young and 13 extend deepest sympathy to the members of his family: to his son, 14 John Young, Jr.; to his daughters, Gaffiny Phillips, Nancy Young, 15 and Mary Patricia Young; to his grandson; and to his other relatives 16 and many friends; and, be it further

17 RESOLVED, That an official copy of this resolution be 18 prepared for the members of his family and that when the Texas House 19 of Representatives adjourns this day, it do so in memory of the 20 Honorable John A. Young.
