## RESOLUTION

1 WHEREAS, The untimely passing of Charles Shannon of San 2 Antonio on February 3, 2003, at the age of 54 brought a great loss to 3 the family, friends, and colleagues of this kind and generous man, 4 and it is with heavy hearts that we bid him farewell; and

5 WHEREAS, A San Antonio native, Mr. Shannon had served as 6 chairman of the board of directors of VIA Metropolitan Transit 7 since January 2001; he was appointed to that organization's board 8 of trustees in 1995 and held numerous other leadership positions 9 during his tenure with VIA; and

10 WHEREAS, Mr. Shannon was affiliated with the YMCA of San 11 Antonio for 37 years, first as a counselor and youth leader and 12 later as executive director of the Davis-Scott branch and district 13 executive for the southern region; his efforts over the course of 14 nearly four decades changed countless lives and earned him the 15 respect and admiration of young and old alike; and

16 WHEREAS, He was in the U.S. Navy from 1970 to 1973 and served 17 in Vietnam on the USS Constellation; after his discharge he began a 18 10-year stint with the Texas Department of Human Resources, during 19 which time he began his pursuit of a degree in sociology from 20 Southwest Texas State University; and

21 WHEREAS, Mr. Shannon's exemplary record of civic service 22 earned him a number of accolades, including the City of San 23 Antonio's "Profile of a Leader for Outstanding Community Work" 24 award, the United African Methodist Immanuel Church's "Man of the

Year" award, and the Texas Legislative Black Caucus's "Outstanding
Texan" award; and

3 WHEREAS, The loss of Charles Shannon has affected a multitude 4 of individuals who benefited from this extraordinary man's 5 passionate commitment to aiding his fellow citizens, and although 6 he will be sorely missed by those who knew and loved him, his spirit 7 will surely live on through his myriad good works and deeds; now, 8 therefore, be it

9 RESOLVED, That the House of Representatives of the 78th Texas 10 Legislature hereby pay tribute to the life of Charles Shannon of San 11 Antonio and extend sympathy to the members of his family: to his 12 wife, Zelma Shannon; to his son, Eric Shannon; and to the many other 13 relatives and friends of this beloved man; and, be it further
