WHEREAS, Known throughout the community as "Mr. Kerrville," 16 Mr. Fournier gave generously of his time and talents in support of 17 18 numerous area organizations; among those who benefited from his membership were the Havre de Grace Maryland Lodge of Elks, No. 1564, 19 Kerrville Elks Lodge No. 2081, Pearl Harbor Survivors Association, 20 21 Inc., Knights of Columbus No. 1492, Kerrville Kiwanis Club, Chemical Corps Association, Hill Country Preservation Society, 22 23 Inc., and the Cowboy Artists of America Museum; and

24 WHEREAS, This esteemed gentleman was also a valued member of
