

R E S O L U T I O N

1           WHEREAS, The passing of Ignacio "Joe" Vallejo, Jr., on  
2 December 11, 2002, at the age of 82, has left a void in the lives of  
3 his family and friends, and it is indeed fitting at this time to  
4 commemorate his long and fruitful life; and

5           WHEREAS, Born January 12, 1920, in Kyle, Mr. Vallejo was a  
6 pioneer in the promotion of Hispanic and Tejano music, booking acts  
7 at El Campo's Pan American Ballroom for nearly 40 years and sharing  
8 music with listeners for 51 years as the host of radio station  
9 KULP's "Pan American Hour"; and

10           WHEREAS, In 1941, he and his wife, Vivian, were united in  
11 matrimony at Our Lady of Guadalupe Catholic Church in Seguin; he  
12 served during World War II as a corporal in the Army Air Corps  
13 before settling in El Campo in 1948; and

14           WHEREAS, Mr. Vallejo was the owner of El Campo Café and,  
15 later, El Campo Restaurant, which he operated until 1971; his true  
16 passion, however, was music, and in 1963 he built the renowned Pan  
17 American Ballroom, which he managed until 1998; and

18           WHEREAS, Such luminaries as Ernest Tubb, Hank Williams, Jr.,  
19 Buck Owens, and Loretta Lynn played the Pan American Ballroom  
20 during its heyday, and now-famous acts such as Little Joe y La  
21 Familia and teen sensation Selena performed at the venue before  
22 gaining widespread fame; and

23           WHEREAS, Mr. Vallejo was a member of St. Robert's Catholic  
24 Church, American Legion Post 251, and Knights of Columbus 2490; he

1 was also the founder and president of the Pan American Scholarship  
2 Fund and was a dedicated supporter of education; and

3 WHEREAS, A man committed to excellence in all his endeavors,  
4 Mr. Vallejo was someone who could be depended on in times of need,  
5 and his contributions to his community and the music industry will  
6 not soon be forgotten; now, therefore, be it

7 RESOLVED, That the House of Representatives of the 78th Texas  
8 Legislature hereby pay tribute to the life of Ignacio "Joe"  
9 Vallejo, Jr., and extend sincere sympathy to the members of his  
10 family: to his wife, Vivian Castellanos Vallejo; to his daughters  
11 and sons-in-law, Dolly and John Cisneros, Janie and Jackie Saucedo,  
12 and Motsy and Virgil Quintero; to his son, Joe Vallejo III, and his  
13 daughter-in-law, Brenda Vallejo; to his sister, Aurora  
14 Castellanos; to his brothers, Elmer Vallejo, Baltimore Vallejo, and  
15 Robert Vallejo; to his grandchildren and their spouses; and to the  
16 other relatives and many friends of this beloved gentleman; and, be  
17 it further
