## RESOLUTION

1 WHEREAS, The passing of Raymond Frank "Buddy" Rau of Columbus 2 on December 20, 2002, at the age of 65 has brought a profound sense 3 of loss to his loved ones and to countless fellow citizens; and

WHEREAS, Born December 11, 1937, Mr. Rau devoted his life to the cause of historic preservation; his interest in this vital work extended as far back as 1962, when he helped to organize the Magnolia Homes Tour (MHT), Inc., now the Columbus Historic Preservation Trust, Inc.; a life member of the organization, he later served as the group's president; and

WHEREAS, Over the years, Mr. Rau became personally involved in the restoration of several historic properties in Columbus; in 1965 he and his parents purchased the Ilse home and he spent nearly four years overseeing work on the building, now known as Raumonda; he later undertook the restoration of two properties that had long been in his mother's family, the Hancock-Heller Home and a general store; and

WHEREAS, Mr. Rau shared his expertise with others as a restoration and landscape consultant from the late 1960s to the 1970s; he also operated The Carriage House and Columbus Flower Shop for 22 years in the store once owned by his maternal grandparents; and

WHEREAS, This distinguished community leader served as president of the City of Columbus Sesquicentennial Celebration in 1973, president of the city's U.S. Bicentennial Celebration in

- 1 1976, and cochairman of the city's 1991-1992 celebration
- 2 commemorating the quincentennial of the first voyage to the New
- 3 World by Christopher Columbus; and
- WHEREAS, A staunch proponent of heritage tourism, Mr. Rau
- 5 played an instrumental role in 1987 in organizing the Texas Pioneer
- 6 Trail, a route linking historic communities in Colorado, Austin,
- 7 Washington, and Fayette counties; in the early 1990s he served as
- 8 tourism director for the Columbus Chamber of Commerce and MHT, and
- 9 in 1996 he helped to organize, and then became executive director
- of, the Columbus Convention and Visitors Bureau (CCVB), an office
- 11 he held until his passing; and
- WHEREAS, While head of the CCVB, Mr. Rau initiated the city's
- 13 Talking House tours and big tree registry, extended the boundaries
- 14 of the town's historic district, and researched and won approval
- for more than 90 state historical markers; and
- 16 WHEREAS, Other organizations with which he was affiliated
- 17 include the Colorado County Historical Commission, German-Texan
- 18 Heritage Society, Columbus Lions Club, and Live Oak Art Center; and
- 19 WHEREAS, Through his tireless commitment to preserving the
- 20 heritage of one of the state's most historic communities, Buddy Rau
- 21 has bequeathed a legacy of immeasurable richness to all Texans, and
- the blessing of his life will be forever cherished by those who were
- 23 privileged to share his love and friendship; now, therefore, be it
- 24 RESOLVED, That the House of Representatives of the 78th Texas
- 25 Legislature hereby pay special tribute to the life of Raymond Frank
- 26 "Buddy" Rau and extend sincere sympathy to his wife, Laura Ann Rau,
- 27 and to the many other relatives and friends of this beloved

- 1 gentleman; and, be it further
- 2 RESOLVED, That an official copy of this resolution be
- 3 prepared for his family and that when the Texas House of
- 4 Representatives adjourns this day, it do so in memory of Raymond
- 5 Frank "Buddy" Rau.
