RESOLUTION

1 WHEREAS, On April 29, 2003, the citizens of Seymour are 2 gathering in Austin to celebrate Seymour Day at the State Capitol, 3 and this event affords an ideal time to recognize the area's many 4 fine attributes; and

5 WHEREAS, Situated in North Central Texas, at the crossroads 6 of State Highway 114 and U.S. Highways 82, 183, 283, and 277, 7 Seymour was founded by settlers from Oregon who originally planned 8 to call their new home Oregon City; and

9 WHEREAS, Seymour is the county seat of Baylor County, which 10 was created in 1858 and named to honor H. W. Baylor, a surgeon with 11 the Texas Rangers; ranchers formed the nucleus of the city's early 12 population, followed by farmers, merchants, and business 13 professionals, and today's economy continues to rely primarily on 14 farming and ranching operations, including cattle, yearlings, and 15 wheat; and

WHEREAS, The Old Settlers' Reunion and Rodeo, established in 16 1896 by retired cowboy Jeff Scott, is a favorite summertime event 17 18 held the second weekend of July; festivities draw participants from throughout the nation to Seymour, which also hosts a dove hunters' 19 in September; area recreation options encompass a 20 breakfast 21 multitude of leisure activities at Lake Kemp and other nearby 22 lakes, as well as excellent hunting and fishing opportunities and an autumn leaves festival in October; and 23

24 WHEREAS, Enhancing the city's vitality are outstanding

educational and medical institutions; three of the Seymour Independent School District's campuses have been rated "exemplary" by the Texas Education Agency while the entire district was granted five stars by *Texas Monthly* magazine and named a top 10 district in its size category; and

6 WHEREAS, The Seymour Rural Health Care System includes 7 exceptional care from the staff of a local clinic, emergency 8 medical services system, and a hospital with an intern program 9 affiliated with John Peter Smith Hospital in Fort Worth and an 10 expanded nursing school connected to Vernon College; and

11 WHEREAS, Residents of Seymour can look with justifiable pride 12 on their community's past, while they eagerly embrace the 13 challenges and opportunities of the years to come, and it gives the 14 members of this chamber great pleasure to salute this fine Texas 15 city; now, therefore, be it
