R E S O L U T I O N

1 WHEREAS, Renato Ramirez of Zapata has contributed greatly to
2 his community, state, and nation through his professional and
3 personal efforts, and he is indeed deserving of special
4 recognition; and

5 WHEREAS, President of IBC Bank Zapata, Mr. Ramirez came to
6 Zapata at the bank's founding in 1983, and he remains a staunch
7 supporter of commercial growth in the border area; before joining
8 the staff of the institution, which today is part of a rapidly
9 growing Texas-owned network of banks, he was a manager of foreign
10 loans to Mexico under the export/import program in Laredo; and

12 years at Laredo State University and Louisiana State University,
13 where he also held the post of associate dean of LSU's Escuela

19 having earned a bachelor's degree from Texas A&M University and a
20 master of business administration degree from The University of
21 Texas; he has also completed graduate studies toward a doctorate in
22 finance and economics at the University of Tennessee; and

23 WHEREAS, This generous individual devotes considerable time
24 to civic endeavors benefiting his fellow citizens; chair of the

1 Zapata County Appraisal District, he has chaired the Improve Falcon
2 Lake Committee and the board of the Zapata County Water, Sewer and
3 Waste Disposal Committee and is an advocate for the issues of water
4 management and quality; and

5 WHEREAS, Mr. Ramirez is a past vice chair of the South Texas
6 Private Industry Council and has served as president of the Zapata
7 County Independent School District board, the Zapata Boys and Girls
8 Club, and the Zapata Golf Club Association; he also is on the boards
9 of the Laredo United Way and the Texas Agricultural Finance
10 Authority; and

11 WHEREAS, Renato Ramirez is truly benefiting countless
12 individuals through his professional and volunteer efforts, and his
13 outstanding service in South Texas is an inspiration to us all; now,
14 therefore, be it
