1           WHEREAS, On May 25, 2003, members of Lighthouse Missionary  
2 Baptist Church in Houston are celebrating the 10th anniversary of  
3 the church's founding, and this joyous event is certain to be a

14 included the following departments and their leaders: Sunday  
15 School, Renita R. McNeese, superintendent; mission society, Ruby  
16 Williams, president; usher board, Hazel Glover, president; nurses  
17 board, Effie Johnson, president; Inspired Voices of Christ Choir,  
18 Elizabeth Dillard, president; youth movement, Michael Jefferson,  
19 president; and announcing clerk, Katie Stevens; and

20           WHEREAS, For much of the first year, services were held at  
21 Hilliard Elementary School, with prayer meetings and Bible study  
22 sessions hosted by members in their homes, and nine years later the  
23 church is located at 9707 North Wayside; and

24           WHEREAS, Since its founding a decade ago, Lighthouse

1 Missionary Baptist Church has provided spiritual leadership,  
2 compassion, and unwavering support to those who have worshiped  
3 there, and the church stands today as a tribute to the dedication  
4 and deep commitment of its members, past and present, who have  
5 devoted their time, energy, prayers, and financial resources to  
6 ensure its continued existence as a house of God; now, therefore, be
