18 classroom, allowing her to explain the abstract theory of
19 mathematics in the context of real-life applications; her insight
20 has proven to be a valuable teaching tool and has undoubtedly

23 WHEREAS, Outside the classroom, Ms. Mohr is not only a member
24 of the Association of Texas Professional Educators and the Parent

1 Teacher Student Association, but also an active volunteer in the
2 community; she attends St. Matthew's Lutheran Church, where she is
3 an assistant AWANA leader and Sunday school teacher; in addition,
4 she is a member of the Weatherford ISD district planning committee
5 and coaches youth league basketball; and

6 WHEREAS, The Weatherford Chamber of Commerce is honoring Ms.
7 Mohr during its Teacher of the Year Luncheon on May 14, 2003, and it
8 is a pleasure to join the chamber in recognizing this outstanding
9 teacher at this time; now, therefore, be it
