

R E S O L U T I O N

1           WHEREAS, The passing of Clotilde Perez "Cleo" Garcia, M.D.,  
2 on May 27, 2003, at the age of 86, has brought a tremendous loss to  
3 the friends, relatives, and admirers of this renowned physician,  
4 civil rights leader, and educator, as well as to the entire State of  
5 Texas; and

6           WHEREAS, Born on January 9, 1917, to a family of teachers, Dr.  
7 Garcia learned at an early age the power of education to transform  
8 the world; a graduate of Mercedes High School, she earned several  
9 degrees at Pan American University and The University of Texas at  
10 Austin, temporarily putting her plans for medical school on hold to  
11 work as a teacher and administrator in South Texas; and

12           WHEREAS, This brilliant and hardworking young woman  
13 fulfilled her ambition to become a doctor in 1954, when she  
14 graduated from The University of Texas School of Medicine in  
15 Galveston; defying the odds, she not only received the title of  
16 Outstanding Medical Student during her first year of studies, but  
17 became one of the Lone Star State's first female doctors of Hispanic  
18 descent; and

19           WHEREAS, Dr. Garcia's illustrious career in medicine was  
20 shaped by her desire to help others, especially those of the most  
21 limited resources, by providing medical education, treatment, and  
22 preventative treatment; the impact she had on those around her can  
23 be inferred from the fact that she delivered more than 10,000 babies  
24 during her decades of practice, which ended in 1994 when she retired

1 to pursue her other interests; and

2 WHEREAS, In addition to her tireless work as a physician and  
3 surgeon, Dr. Garcia applied her phenomenal intelligence and focus  
4 to genealogical research and to the task of chronicling the history  
5 of the greater Corpus Christi area; her collection of historical  
6 papers and books is today housed at Texas A&M University--Corpus  
7 Christi, a substantial legacy that will benefit the citizens of  
8 Texas for many years to come; and

9 WHEREAS, Not content with being merely an accomplished  
10 physician, educator, historian, and scholar, Dr. Garcia was also a  
11 devoted community advocate and civil rights leader; she was the  
12 former national health director of LULAC and a member of the Nueces  
13 County Anti-Poverty Program Board of Directors, the Texas  
14 Constitution Revision Commission, and the Task Force to Evaluate  
15 Medicaid in Texas; and

16 WHEREAS, Those who had the privilege of knowing "Dr. Cleo,"  
17 as she was affectionately known to so many, will never forget the  
18 passion, enthusiasm, and commitment that this talented woman  
19 brought to every single facet of her life; although her presence is  
20 gone from us now, her work will endure for generations to come, and  
21 her memory will live on in the hearts of the many thousands of  
22 Texans whose lives she touched during her years on this earth; now,  
23 therefore, be it

24 RESOLVED, That the House of Representatives of the 78th Texas  
25 Legislature hereby pay special tribute to the life of Dr. Clotilde  
26 Perez "Cleo" Garcia of Corpus Christi and extend profound sympathy  
27 to her family: to her son, Jose Antonio "Tony" Canales; to her

2 Barbara Ann and Patricia Marie; to her grandson, Hector Antonio; to  
3 her sisters, Dr. Dalia P. Garcia and Emilia Garcia Garza; to her  
4 brother, Dr. Cuitlahuac P. Garcia; and to the many relatives,  
5 friends, colleagues, and admirers of this remarkable Texan; and, be
