Suspending limitations on conference committee jurisdiction, H.B. No. 1695 (Denny/Nelson)

RESOLUTION

BE IT RESOLVED by the House of Representatives of the State of
Texas, 78th Legislature, Regular Session, 2003, That House Rule 13,
Section 9(a), be suspended in part as provided by House Rule 13,
Section 9(f), to enable the conference committee appointed to
resolve the differences on House Bill 1695, relating to certain
election processes and procedures, to consider and take action on
the following matter:

- 8 (1) House Rule 13, Section 9(a)(2), is suspended to permit
 9 the committee to omit text amending Sections 2.051(b) and 2.053(c),
 10 Election Code, that reads as follows:
- 11 [Sec. 2.051]
- In the case of an election in which any members of the 12 political subdivision's governing 13 body are elected from 14 territorial units such as single-member districts, this subchapter election 15 applies to the in a particular territorial unit [single-member district] if[⋅ 16
- [(1)] each candidate whose name is to appear on the ballot in that territorial unit [district] is unopposed and no at-large proposition or opposed at-large race is to appear on the ballot. This subchapter applies to an unopposed at-large race in such an election regardless of whether an opposed race is to appear on the ballot in a particular territorial unit[; and
- [(2) the requirements prescribed by Subsection (a) are otherwise met].

- 2 (c) A certificate of election shall be issued to each
- 3 candidate in the same manner and at the same time as provided for a
- 4 candidate elected at the election. The candidate must qualify for
- 5 the office in the same manner as provided for a candidate elected at
- 6 the election.
- 7 Explanation: The omission of these sections is necessary
- 8 since the amended sections are to be repealed by a previous
- 9 enactment of the 78th Legislature.
- 10 (2) House Rule 13, Section 9(a)(4), is suspended to permit
- 11 the committee to add a new section amending Section 19.004,
- 12 Election Code, to read as follows:
- SECTION 10. Section 19.004, Election Code, is amended by
- 14 amending Subsection (a) and adding Subsection (d) to read as
- 15 follows:
- 16 (a) Except as provided by Subsection (d), state [State]
- 17 funds disbursed under this chapter may be used only to defray
- 18 expenses of the registrar's office in connection with voter
- 19 registration, including additional expenses related to:
- 20 (1) implementation of the National Voter Registration
- 21 Act of 1993 (42 U.S.C. Section 1973gg et seq.); and
- 22 (2) complying with the weekly updating requirements
- prescribed by Section 18.063.
- 24 (d) If the secretary of state determines that federal
- 25 <u>matching funds are available under the federal Help America Vote</u>
- 26 Act of 2002, the secretary of state shall certify to the comptroller
- 27 the amount of state funds required to qualify for the maximum amount

- of federal matching funds. On receipt of the certification, the
- 2 comptroller shall deposit from funds otherwise available under this
- 3 chapter an amount equal to the certified amount in the election
- 4 improvement fund established under Section 31.011.
- 5 Explanation: The addition of the new section is necessary to
- 6 enable the state to be eligible to receive federal funds for
- 7 election improvements beginning on September 1, 2003.

- (3) $\left[\frac{4}{4}\right]$ an election held under an order of a court or
- 12 other tribunal;
- (4) $\left[\frac{(5)}{(5)}\right]$ an emergency election ordered under Section
- 14 41.0011;
- 15 $\underline{(5)}$ [$\overline{(6)}$] an expedited election to fill a vacancy in
- the legislature held under Section 203.013; or
- 17 (6) $[\frac{(7)}{}]$ an election held under a statute that
- 18 expressly provides that the requirement of Subsection (a) does not
- 19 apply to the election.
- SECTION 17. Section 41.001(e), Election Code, is amended to
- 21 read as follows:
- (e) In addition to a date prescribed by Subsection (a), an
- 23 [An] election for an office in which a majority vote is required and
- 24 that is [may not be held on the September or February uniform
- 25 election date. This subsection does not apply to an election]
- 26 conducted under Section 26.045, Local Government Code, may be held
- 27 on the first Saturday in February or the second Saturday in

- 1 September, which are considered to be dates that comply with
- 2 Subsection (a) and Section 26.045, Local Government Code.
- 3 Explanation: The additional new sections are necessary to
- 4 provide for greater efficiency in holding elections by reducing the

- 8 the committee to add a new section amending Section 41.007(b),
- 9 Election Code, to read as follows:
- SECTION 18. Section 41.007(b), Election Code, is reenacted

- 12 (b) The runoff primary election date is the second Tuesday
- in April following the general primary election.
- 14 Explanation: The added section is necessary to resolve a
- 15 conflict between two previous enactments of the 78th Legislature
- 16 relating to the date of the primary run-off election.
- 17 (5) House Rule 13, Section 9(a)(4), is suspended to permit
- 18 the committee to add new sections amending Section 41.253(b),
- 19 Education Code, and Sections 49.103(b) and 56.804(a), Water Code,
- 20 to read as follows:
- 21 SECTION 46. Section 41.253(b), Education Code, is amended
- 22 to read as follows:
- (b) The transitional board of trustees shall divide the
- 24 consolidated district into nine single-member trustee districts in
- 25 accordance with the procedures provided by Section 11.052. The
