1 WHEREAS, Edelmiro Eusebio "Eddie" Garza of Mission passed
2 away on April 26, 2003, at the age of 81, and his family and friends
3 deeply mourn this great loss; and

4 WHEREAS, Born on March 5, 1922, in Mission, Mr. Garza
5 graduated as valedictorian from Sharyland High School and attended
6 McAllen Business College; and

7 WHEREAS, In 1940, he began working for the John H. Shary
8 organization, which he left to serve in the U.S. Navy from
9 1942-1945; during his service, he trained in the Navy Electrical
10 School at the University of Minnesota and at the Teletype
11 Corporation in Chicago and served in the South Pacific; after
12 completion of his military duty, Mr. Garza resumed his employment
13 with the Shary and Shivers organization, where he stayed until
14 1998; and

15 WHEREAS, An active and valued member of his community, Mr.
16 Garza served for 15 years on Mission's Planning and Zoning Board and
17 was treasurer for the new Mission Historical Museum; a member of the
18 American Legion, he also belonged to the Catholic War Veterans,
19 Roberto Gonzales Post 1065, and served as commander, state
20 commander, and treasurer; and

21 WHEREAS, Throughout his life, Mr. Garza contributed greatly
22 to the betterment of his community, and he positively influenced
23 the lives of countless others; now, therefore, be it
