## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the creation, administration, powers, duties,
- 3 operation, and financing of Elgin Municipal Utility District No. 1.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. CREATION.
- 6 (a) A conservation and reclamation district, to be known as
- 7 Elgin Municipal Utility District No. 1, is created in Bastrop
- 8 County, Texas, subject to approval by the City of Elgin as provided
- 9 in Section 7 of this Act and voter approval at a confirmation
- 10 election as provided in Section 10 of this Act. The district is a
- 11 governmental agency and a body politic and corporate.
- 12 (b) The district is created under and is essential to
- 13 accomplish the purposes of Article XVI, Section 59, of the Texas
- 14 Constitution.
- 15 SECTION 2. DEFINITION. In this Act, "district" means Elgin
- 16 Municipal Utility District No. 1.
- 17 SECTION 3. BOUNDARIES. The district includes the territory
- 18 contained within the following area:

- CONTAINING, within these metes and bounds 384.83 acres of
- 24 land area.
- THIS DESCRIPTION WAS PREPARED FROM THE DEEDS OF RECORD AND
- 26 DOES NOT PURPORT TO BE AN ON-THE-GROUND SURVEY.
- 27 SECTION 4. FINDINGS RELATING TO BOUNDARIES. The

- 1 legislature finds that the boundaries and field notes of the
- 2 district form one or more closures. A mistake in the field notes or
- 3 in copying the field notes in the legislative process does not
- 4 affect the organization, existence, or validity of the district,
- 5 the right of the district to levy and collect taxes, or the legality
- 6 or operation of the district or its governing body.
- 7 SECTION 5. FINDING OF BENEFIT. All of the land and other
- 8 property included within the boundaries of the district will be
- 9 benefitted by the works and projects that are to be accomplished by
- 10 the district under the powers conferred by Article XVI, Section 59,
- 11 of the Texas Constitution. The district is created to serve a
- 12 public use and benefit.
- 13 SECTION 6. POWERS.
- 14 (a) The district has all of the rights, powers, privileges,
- 15 authority, functions, and duties provided by the general law of
- this state, including Chapters 49 and 54, Water Code, applicable to
- 17 municipal utility districts created under Article XVI, Section 59,
- 18 of the Texas Constitution.
- 19 (b) The district created under this Act is wholly located
- 20 within the area of extra-territorial jurisdiction of the City of
- 21 Elgin. Creation of the district is subject to approval of the City
- of Elgin, as provided in Section 42.042, Local Government Code and
- 23 54.016, Water Code,. Subject to approval by the City of Elgin, the
- 24 district has the power and authority to divide into two or more
- 25 districts following the procedure set forth in Sections 51.749
- 26 through 51.758, Water Code, without any further approval or
- 27 consent. The district is further subject to the requirements of

- 1 municipal ordinances of the City of Elgin applicable to
- 2 extra-territorial areas, unless the municipality's governing body
- 3 waives compliance.
- 4 (c) The rights, powers, privileges, authority, functions,
- 5 and duties of the district are subject to the continuing right of
- 6 supervision of the state to be exercised by and through the Texas
- 7 Commission on Environmental Quality.
- 8 (d) This Act prevails over any provision of general law that
- 9 is in conflict or inconsistent with this Act.
- 10 SECTION 7. DEVELOPMENT AGREEMENT. The district, and/or the
- 11 owners of land within the district, may enter into written
- 12 contracts with any municipality within whose extraterritorial
- 13 jurisdiction the district is located, in whole or in part:
- 14 (a) to guarantee the continuation of the extraterritorial
- 15 status of the district and its immunity from annexation by the
- 16 municipality for a period not to exceed 25 years;
- 17 (b) regulating the development within the boundaries of the
- district in a manner that the parties agree will further the health,
- 19 safety and welfare of the residents of the district;
- 20 (c) containing other terms and consideration that the
- 21 district and the municipality agree to be reasonable and
- 22 appropriate; and
- 23 (d) which may be renewed or extended for successive periods
- of time not to exceed 15 years.
- 25 A municipality may contract with the district, and/or the
- owners of the land within the district, to accomplish the purposes
- 27 set forth above.

- 1 SECTION 8. BOARD OF DIRECTORS.
- 2 (a) The district is governed by a board of five directors.
- 3 (b) Temporary directors serve until initial permanent
- 4 directors are elected under Section 10 of this Act.
- 5 (c) Initial permanent directors serve until permanent
- 6 directors are elected under Section 11 of this Act.
- 7 (d) Permanent directors other than initial permanent
- 8 directors serve staggered four-year terms.
- 9 (e) Each director must qualify to serve as director in the
- 10 manner provided by Section 49.055, Water Code.
- 11 (f) A director serves until the director's successor has
- 12 qualified.
- SECTION 9. TEMPORARY DIRECTORS. (a) The temporary board
- 14 of directors is composed of:
- 15 (1) Gary Jones;
- 16 (2) Harry Turner;
- 17 (3) Stan McElroy;
- 18 (4) Billy Ray Walker; and
- 19 (5) Richard Fadal.
- 20 (b) If a temporary director fails to qualify for office, the
- 21 temporary directors who have qualified shall appoint a person to
- 22 fill the vacancy. If at any time there are fewer than three
- 23 qualified temporary directors, the Texas Commission on
- 24 Environmental Quality shall appoint the necessary number of persons
- 25 to fill all vacancies on the board.
- 26 SECTION 10. CONFIRMATION AND INITIAL DIRECTORS ELECTION.
- 27 The temporary board of directors shall call and hold an election to

- 1 confirm establishment of the district and to elect five initial
- directors as provided by Chapter 49, Water Code.
- 3 SECTION 11. ELECTION OF DIRECTORS. On the first Saturday in
- 4 May of the first even-numbered year occurring at least three years
- 5 after the year in which the confirmation election is held, an
- 6 election shall be held in the district for the election of two
- 7 directors who shall each serve two-year terms and three directors
- 8 who shall each serve four-year terms. Thereafter, on the same date
- 9 in each subsequent even-numbered year, the appropriate number of
- 10 directors shall be elected to the board.
- 11 SECTION 12. FINDINGS RELATING TO PROCEDURAL REQUIREMENTS.
- 12 (a) The proper and legal notice of the intention to introduce this
- 13 Act, setting forth the general substance of this Act, has been
- 14 published as provided by law, and the notice and a copy of this Act
- 15 have been furnished to all persons, agencies, officials, or
- 16 entities to which they are required to be furnished by the
- 17 constitution and other laws of this state, including the governor,
- 18 who has submitted the notice and Act to the Texas Commission on
- 19 Environmental Quality.
- 20 (b) The Texas Commission on Environmental Quality has filed
- 21 its recommendations relating to this Act with the governor,
- 22 lieutenant governor, and speaker of the house of representatives
- 23 within the required time.
- (c) All requirements of the constitution and laws of this
- 25 state and the rules and procedures of the legislature with respect
- 26 to the notice, introduction, and passage of this Act are fulfilled
- 27 and accomplished.

SECTION 13. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2003.
