- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 551.121, Government Code, is amended by
- 7 amending Subsections (b)-(f) and adding Subsection (g) to read as
- 8 follows:
- 9 Sec. 551.121. GOVERNING BOARD OF INSTITUTION OF HIGHER
- 10 EDUCATION.
- 11 (b) This chapter does not prohibit the governing board of an
- 12 institution of higher education from holding an open or closed
- 13 meeting by telephone conference call or videoconference.
- 14 (c) A meeting held by telephone conference call or
- 15 videoconference may be held only if:
- 16 (1) the meeting is a special called meeting $\underline{}_{\underline{}}$ [and]
- immediate action is required, [+] and
- 18 $\left[\frac{(2)}{2}\right]$ the convening at one location of a quorum of the
- 19 governing board is difficult or impossible; or
- 20 (2) the governing board determines that, for an
- 21 academic or other policy reason, it is appropriate for a quorum of
- 22 the governing board to meet at a physical location outside the
- 23 geographical boundaries of the state, including a location in a
- 24 <u>foreign country</u>.

- 1 (d) The telephone conference call <u>or videoconference</u> 2 meeting is subject to the notice requirements applicable to other
- 3 meetings.
- 4 (e) The notice of the telephone conference call or
- 5 <u>videoconference</u> meeting must specify as the location of the meeting
- 6 the location where meetings of the governing board are usually
- 7 held. For a meeting of the governing board of a university system,
- 8 the notice must specify as the location of the meeting the board's
- 9 conference room at the university system office. For a meeting held
- 10 under Subsection (c)(2), the notice must also specify the physical
- 11 location where a quorum of the governing board will meet and the
- 12 reason for which the governing board determined to meet at that
- 13 physical location.
- 14 (f) Each part of a [the] telephone conference call meeting
- that is required to be open to the public shall be audible to the
- 16 public at the location specified in the notice of the meeting as the
- 17 location of the meeting and shall be tape recorded. The tape
- 18 recording shall be made available to the public.
- 19 (g) Each part of a videoconference meeting that is required
- 20 to be open to the public shall:
- 21 (1) be visible and audible to the public at the
- location specified in the notice of the meeting as the location of
- 23 the meeting;
- 24 (2) be recorded in an audiovisual medium that records
- 25 the meeting substantially as presented under Subdivision (1) and
- that shall be made available to the public; and
- 27 (3) have two-way audio and video communications with

- 1 <u>each participant in the meeting during the entire meeting.</u>
- 2 SECTION 2. This Act takes effect September 1, 2003, and
- 3 applies only to a meeting for which notice is given on or after that
- 4 date.
