1-10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-11 SECTION 1. Section 46.002, Government Code, is amended to
1-12 read as follows:

1-13 Sec. 46.002. PROSECUTORS SUBJECT TO CHAPTER. This chapter
1-14 applies to all county prosecutors and to the following state
1-15 prosecutors:

1-24 (2) the criminal district attorneys for the counties
1-25 of Anderson, Austin, Bastrop, Bexar, Bowie, Brazoria, Caldwell,
1-26 Calhoun, Cass, Collin, Comal, Dallas, Deaf Smith, Denton, Eastland,
1-27 Galveston, Gregg, Harrison, Hays, Hidalgo, Jasper, Jefferson,
1-28 Kaufman, Lubbock, McLennan, Madison, Navarro, Newton, Panola,
1-29 Polk, Randall, Rockwall, San Jacinto, Smith, Tarrant, Taylor,
1-30 Tyler, Upshur, Van Zandt, Victoria, Walker, Waller, Wichita, Wood,
1-31 and Yoakum; and

1-32 (3) the county attorneys performing the duties of
1-33 district attorneys in the counties of Andrews, Callahan, Cameron,
1-34 Castro, Colorado, Crosby, Ellis, Falls, Fannin, Freestone,
1-35 Grayson, Lamar, Lamb, Lampasas, Lee, Limestone, Marion, Milam,
1-36 Morris, Ochiltree, Orange, Rains, Red River, Robertson, Rusk,
1-37 Terry, Webb, and Willacy.
