A BILL TO BE ENTITLED

- 2 relating to the regulation and enforcement of the practice of
- 3 medicine by the Texas State Board of Medical Examiners.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subdivision (2), Subsection (a), Section
- 6 151.002, Occupations Code, is amended to read as follows:
- 7 (2) "Continuing threat to the public welfare" means a
- 8 real [and present] danger to the health of a physician's patients or
- 9 to the public from the acts or omissions of the physician caused
- 10 through the physician's lack of competence, impaired status, or
- 11 failure to care adequately for the physician's patients, as
- 12 determined by:
- 13 (A) the board;
- 14 (B) a medical peer review committee in this
- 15 state;
- 16 (C) a physician licensed to practice medicine in
- 17 this state or otherwise lawfully practicing medicine in this state;
- 18 (D) a physician engaged in graduate medical
- 19 education or training; or
- 20 (E) a medical student.
- 21 SECTION 2. Subsection (d), Section 153.051, Occupations
- 22 Code, is amended to read as follows:
- 23 (d) The board may not set, charge, collect, receive, or
- 24 deposit any of the following fees in excess of:

- 1 (1) \$900 for a license;
- 2 (2) $\frac{$400}{}$ [\$\frac{\$200}{}] for a first [\frac{annual}{}] registration
- 3 permit;
- 4 (3) \$200 for a temporary license;
- 5 (4) $\frac{$400}{}$ [\$\frac{\$200}{}] for renewal of a [an annual]
- 6 registration permit;
- 7 (5) \$200 for a physician-in-training permit;
- 8 (6) $\frac{$600}{}$ [\$\frac{\$300}{}] for the processing of an application
- 9 and the issuance of \underline{a} [an annual] registration for anesthesia in an
- 10 outpatient setting;
- 11 (7) \$200 for an endorsement to other state medical
- 12 boards;
- 13 (8) \$200 for a duplicate license; or
- 14 (9) \$700 for a reinstated license after cancellation
- 15 for cause.
- SECTION 3. Section 153.053, Occupations Code, is amended to
- 17 read as follows:
- 18 Sec. 153.053. SURCHARGE FOR CERTAIN FEES. (a) The board
- 19 shall collect a fee [an additional \$200] surcharge as follows [for
- 20 <u>each of the following fees</u>]:
- 21 (1) <u>\$200 for the license fee;</u>
- 22 (2) \$400 for the first [annual] registration permit;
- 23 (3) \$400 for renewal of a [annual] registration
- 24 permit; and
- 25 (4) \$200 for reinstatement of a license after
- 26 cancellation for cause.
- 27 (b) Of each surcharge collected under Subsections (a)(1)

- and (4), the board shall deposit \$50 to the credit of the foundation
- 2 school fund and \$150 to the credit of the general revenue fund.
- 3 (c) Of each surcharge collected under Subsections (a)(2)
- 4 and (3), the board shall deposit \$100 to the credit of the
- 5 foundation school fund and \$300 to the credit of the general revenue
- 6 fund.
- 7 SECTION 4. Subchapter B, Chapter 153, Occupations Code, is
- 8 amended by adding Section 153.0535 to read as follows:
- 9 Sec. 153.0535. SURCHARGE FOR REGISTRATION PERMIT. (a) The
- 10 board shall collect an additional \$30 surcharge for each of the
- following fees:
- 12 <u>(1)</u> first registration permit; and
- 13 (2) renewal of a registration permit.
- 14 (b) The board shall deposit each surcharge collected to the
- 15 credit of the public assurance account. The public assurance
- 16 account is an account in the general revenue fund that shall be
- appropriated only to the board to pay for the board's enforcement
- 18 program, including the expert physician panel.
- 19 SECTION 5. Section 153.055, Occupations Code, is amended by
- 20 adding Subsection (c) to read as follows:
- 21 (c) The board shall include in the report information
- 22 regarding any investigations that remain pending after one year,
- 23 including the reasons the investigations remain pending.
- SECTION 6. Subsection (a), Section 154.002, Occupations
- 25 Code, is amended to read as follows:
- 26 (a) The board shall prepare:
- 27 (1) an alphabetical list of the names of the license

- 1 holders;
- 2 (2) an alphabetical list of the names of the license
- 3 holders by the county in which the license holder's principal place
- 4 of practice is located;
- 5 (3) a summary of the board's functions;
- 6 (4) a copy of this subtitle and a list of other laws
- 7 relating to the practice of medicine;
- 8 (5) a copy of the board's rules; [and]
- 9 (6) <u>a statistical report each fiscal year to the</u>
- 10 legislature and the public that provides aggregate information
- 11 about all complaints received by the board categorized by type of
- 12 complaint, including administrative, quality of care, medical
- 13 error, substance abuse, other criminal behavior, and the
- 14 disposition of those complaints by category; and
- 15 (7) other information considered appropriate by the
- 16 board.
- 17 SECTION 7. Subsection (b), Section 154.006, Occupations
- 18 Code, is amended to read as follows:
- 19 (b) A profile must contain the following information on each
- 20 physician:
- 21 (1) the name of each medical school attended and the
- 22 dates of:
- 23 (A) graduation; or
- 24 (B) Fifth Pathway designation and completion of
- 25 the Fifth Pathway Program;
- 26 (2) a description of all graduate medical education in
- 27 the United States or Canada;

- 1 (3) any specialty certification held by the physician
- 2 and issued by a medical licensing board that is a member of the
- 3 American Board of Medical Specialties or the Bureau of Osteopathic
- 4 Specialists;
- 5 (4) the number of years the physician has actively
- 6 practiced medicine in:
- 7 (A) the United States or Canada; and
- 8 (B) this state;
- 9 (5) the name of each hospital in this state in which
- 10 the physician has privileges;
- 11 (6) the physician's primary practice location;
- 12 (7) the type of language translating services,
- 13 including translating services for a person with impairment of
- 14 hearing, that the physician provides at the physician's primary
- 15 practice location;
- 16 (8) whether the physician participates in the Medicaid
- 17 program;
- 18 (9) a description of any conviction for a felony, a
- 19 Class A or Class B misdemeanor, or a Class C misdemeanor involving
- 20 moral turpitude during the 10-year period preceding the date of the
- 21 profile;
- 22 (10) a description of any charges reported to the
- 23 board during the 10-year period preceding the date of the profile to
- 24 which the physician has pleaded no contest, for which the physician
- 25 is the subject of deferred adjudication or pretrial diversion, or
- 26 in which sufficient facts of guilt were found and the matter was
- 27 continued by a court;

- 1 (11) a description of any disciplinary action against
- 2 the physician by the board during the 10-year period preceding the
- 3 date of the profile;
- 4 (12) a description of any disciplinary action against
- 5 the physician by a medical licensing board of another state during
- 6 the 10-year period preceding the date of the profile;
- 7 (13) a description of the final resolution taken by
- 8 the board on medical malpractice claims or complaints required to
- 9 be opened by the board under Section 164.201;
- 10 (14) whether the physician's patient service areas are
- 11 accessible to disabled persons, as defined by federal law; [and]
- 12 (15) a description of any formal complaint against the
- 13 physician initiated and filed under Section 164.005 and the status
- of the complaint; and
- 15 (16) a description of any medical malpractice claim
- against the physician, not including a description of any offers by
- the physician to settle the claim, for which the physician was found
- 18 liable, a jury awarded monetary damages to the claimant, and any
- 19 such award was determined to be final, and not subject to further
- 20 <u>appeal</u>.
- 21 SECTION 8. Section 154.054, Occupations Code, is amended to
- 22 read as follows:
- Sec. 154.054. COMPLAINT INFORMATION TO HEALTH CARE ENTITY.
- 24 On written request, the board shall provide information to a health
- 25 care entity regarding:
- 26 (1) a complaint filed against a license holder that
- 27 was resolved after investigation by:

- 2 (B) an agreed settlement; and
- 3 (2) the basis of and current status of any complaint 4 under active investigation that has been assigned by the executive 5 director to a person authorized by the board to pursue legal action.
- SECTION 9. Section 154.056, Occupations Code, is amended by amending Subsection (a) and adding Subsections (e) and (f) to read as follows:
- 9 (a) The board shall adopt rules concerning the 10 investigation and review of a complaint filed with the board. The 11 rules adopted under this section must:
- (1) distinguish among categories of complaints <u>and</u>
 give priority to complaints that involve sexual misconduct, quality
 of care, and impaired physician issues;
- 15 (2) ensure that a complaint is not dismissed without 16 appropriate consideration;
- 17 (3) require that the board be advised of the dismissal
 18 of a complaint and that a letter be sent to the person who filed the
 19 complaint and to the physician who was the subject of the complaint
 20 explaining the action taken on the complaint;
- 21 (4) ensure that a person who files a complaint has an opportunity to explain the allegations made in the complaint; [and]
- (5) prescribe guidelines concerning the categories of complaints that require the use of a private investigator and the procedures for the board to obtain the services of a private investigator;
- 27 (6) provide for an expert physician panel authorized

- 1 under Subsection (e) to assist with complaints and investigations
- 2 relating to medical competency; and
- 3 (7) require review of reports filed with the National
- 4 Practitioner Data Bank for any reports of termination, limitation,
- 5 suspension, limitations in scope of practice and/or probation of
- 6 clinical or hospital staff privileges of a physician by any
- 7 hospital, health maintenance organization, Independent Physician
- 8 Association, Section 5.01(a) organization, or physician network.
- 9 (e) The board by rule shall provide for an expert physician
- 10 panel appointed by the board to assist with complaints and
- 11 <u>investigations relating to medical competency</u>. Each member of an
- 12 expert physician panel must be licensed to practice medicine in
- 13 this state. The rules adopted under this subsection must include
- 14 provisions governing the composition of the panel, qualifications
- for membership on the panel, and the duties to be performed by the
- 16 panel.
- (f) In the board rules adopted under Subsection (a)(3), the
- 18 board shall require that the letter informing the person who filed
- 19 the complaint of the dismissal of the complaint include an
- 20 explanation of the reason the complaint was dismissed.
- 21 SECTION 10. Section 154.058, Occupations Code, is amended
- 22 to read as follows:
- Sec. 154.058. DETERMINATION OF MEDICAL COMPETENCY.
- 24 <u>(a)</u> Each complaint against a physician that requires a
- 25 determination of medical competency shall be reviewed initially by
- 26 a board member, consultant, or employee with a medical background
- 27 considered sufficient by the board.

- that an act by a physician falls below an acceptable standard of care, the complaint shall be reviewed by an expert physician panel authorized under Section 154.056(e) consisting of physicians who practice in the same specialty as the physician who is the subject of the complaint or in another specialty that is similar to the physician's specialty.
- 9 panel's determinations based on the review of the complaint under
 10 Subsection (b). The report must specify the standard of care that
 11 applies to the facts that are the basis of the complaint and the
 12 clinical basis for the panel's determinations, including any
 13 reliance on peer-reviewed journals, studies, or reports.

- SECTION 12. Section 156.001, Occupations Code, is amended to read as follows:
- Sec. 156.001. [ANNUAL] REGISTRATION REQUIREMENTS AND PROCEDURES [REQUIRED; REGISTRATION PROCEDURE]. (a) Each person
- 21 licensed to practice medicine in this state must register with the
- 22 board <u>every two years</u> [annually]. The initial [annual]
- 23 registration permit shall be issued with the license <u>and expires on</u>
- 24 the last day of the birth month of the license holder.
- (b) Except as provided by Section 156.002, the application for registration must be accompanied by <u>a</u> [an annual] registration permit fee in an amount set by the board regardless of whether the

- 1 person is practicing medicine in this state.
- 2 (c) A license holder may renew the [annual] registration
- 3 permit by submitting to the board, on or before the expiration date
- 4 of the [annual] registration permit, the required renewal
- 5 application and <u>registration</u> renewal fee. Each [annual]
- 6 registration permit renewal application must include:
- 7 (1) the license holder's name, [and] mailing address,
- 8 and, if one is available, address for receipt of electronic mail;
- 9 (2) the <u>primary</u> place [or places] at which the license
- 10 holder is engaged in the practice of medicine; and
- 11 (3) other necessary information as prescribed by [the]
- 12 board rule.
- 13 (d) If the license holder [person] is licensed to practice
- 14 medicine by another state or country or by the uniformed services of
- 15 the United States, the registration renewal application must
- 16 include a description of any investigation the <u>license holder</u>
- 17 [person] knows is in progress and any sanction imposed by or
- 18 disciplinary matter pending in the state, country, or service
- 19 regarding the license holder [person].
- SECTION 13. Section 156.002, Occupations Code, is amended
- 21 to read as follows:
- Sec. 156.002. EXEMPTION FOR CERTAIN PHYSICIANS. (a) The
- 23 board by rule may exempt a retired physician from the [annual]
- 24 registration permit fee requirement.
- 25 (b) A physician licensed by the board whose only practice is
- voluntary charity care, as defined by board rule, is exempt from the
- 27 [annual] registration permit fee requirement.

- 3 Sec. 156.003. STAGGERED RENEWAL SYSTEM. (a) The board by
- 4 rule may adopt a system under which [annual] registration permits
- 5 expire on various dates during the two-year registration period
- 6 [year].
- 7 (b) For the $\underline{registration period}$ [\underline{year}] in which the
- 8 expiration date is changed, [annual] registration permit fees shall

- 18 30-day grace period for renewing the [annual] registration permit
- 19 from the date of the expiration of the permit.
- 20 SECTION 16. Section 156.005, Occupations Code, is amended
- 21 to read as follows:
- Sec. 156.005. RENEWAL OF CERTAIN REGISTRATION PERMITS.
- 23 (a) If a person's [annual] registration permit has been expired
- for 90 days or less, the person may renew the permit by submitting
- 25 to the board the required registration renewal application, the
- registration renewal fee, and a \$75 [\$50] penalty fee.
- 27 (b) If the person's [annual] registration permit has been

- 1 expired for longer than 90 days but less than one year, the person
- 2 may renew the permit by submitting to the board the required
- 3 registration renewal application, the registration renewal fee,
- 4 and a \$150 $\left[\frac{$100}{}\right]$ penalty fee.
- 5 (c) If the person's [annual] registration permit has been
- 6 expired for one year or longer, the person's license is

- 8 investigation is pending, and the person may not renew the [annual]

- 10 (d) A physician whose license is automatically [considered]
- 11 canceled may obtain a new license by [submitting to reexamination
- 12 and complying with the requirements, fees, and procedures for
- obtaining a new license. The board may issue a new license without
- examination to a person whose license is automatically [considered]
- 15 canceled for less than two years.
- 16 SECTION 17. Section 156.007, Occupations Code, is amended
- 17 to read as follows:
- 18 Sec. 156.007. ISSUANCE OF [ANNUAL] REGISTRATION PERMIT.
- 19 (a) On receipt of a registration renewal application and all

- 5 SECTION 20. Subsections (a) and (d), Section 156.051,

- 18 (3) medical practice and residence outside the United
- 19 States for longer than one year; or
- 20 (4) good cause shown on the written application of the
- 21 license holder that provides evidence satisfactory to the board
- that the license holder is unable to comply with the requirement.
- 23 (b) A temporary exemption granted under Subsection (a) may
- not exceed one year but may be renewed [annually].
- 25 SECTION 23. Subsection (a), Section 160.052, Occupations
- 26 Code, is amended to read as follows:
- 27 (a) Each insurer shall submit to the board the report or

- 1 other information described by Section 160.053 at the time
- 2 prescribed. The insurer shall provide the report or information
- 3 with respect to:
- 4 (1) a [notice of claim letter or] complaint filed
- 5 against an insured in a court, if the [notice of claim letter or]
- 6 complaint seeks damages relating to the insured's conduct in
- 7 providing or failing to provide a medical or health care service;
- 8 and
- 9 (2) settlement of a claim $\underline{\text{without the filing of a}}$
- 10 lawsuit or settlement of a lawsuit made on behalf of the insured
- 11 <u>involving damages relating to the insured's conduct in providing or</u>
- 12 <u>failing to provide a medical or health care service.</u>

- 17 from an insured a [notice of claim letter or] complaint filed in a
- lawsuit, the date of a settlement of a claim without the filing of a
- 19 lawsuit, or the date of a settlement of a lawsuit against the [from
- 20 an] insured, the insurer shall furnish to the board:
- 21 (1) the name of the insured and the insured's Texas
- 22 medical license number;
- 23 (2) the policy number; [and]
- 24 (3) a copy of the [notice of claim letter or] complaint
- or settlement; and
- 26 (4) a copy of any expert report filed pursuant to

- 2 (b) The board, in consultation with the commissioner, shall

- 6 determining the information to be reported, form of the report, and
- 7 frequency of reporting. Additional information which the board
- 8 <u>shall require must</u> [requires may] include:
- 9 (1) the date of a judgment, dismissal, or settlement;
- 10 (2) whether an appeal has been taken and by which
- 11 party; and
- 12 (3) the amount of the settlement or judgment against
- 13 the insured.
- 14 SECTION 25. Subsection (a), Section 162.104, Occupations

- 19 disciplinary action by the board, the board shall schedule the
- 20 informal meeting as soon as practicable but not later than the
- 21 deadline prescribed by Subsection (b)(1).
- 22 SECTION 28. Subchapter A, Chapter 164, Occupations Code, is
