- SECTION 2. Subsections (b) and (g), Section 531.052,

- 12 (b) The work group is composed of:
- 13 (1) representatives of the commission, appointed by
- 14 the commissioner;
- 15 (2) representatives of the Texas Department of Human
- 16 Services, appointed by the commissioner of that agency;
- 17 (3) representatives of the Texas Department of Mental
- 18 Health and Mental Retardation, appointed by the commissioner of
- 19 that agency;
- 20 (4) representatives of the Texas Department of Health,
- 21 appointed by the commissioner of that agency;
- 22 (5) representatives of the Texas Rehabilitation
- 23 Commission, appointed by the commissioner of that agency;
- 24 (6) consumers of services provided under the voucher

- 1 payment pilot project under former Section 22.0325, Human Resources
- 2 Code, jointly appointed by the commissioner and the commissioner of
- 3 the Texas Department of Human Services;
- 4 (7) persons with disabilities, including persons with
- 5 mental illness and persons with mental retardation, who are
- 6 consumers or potential consumers of services provided under the
- 7 voucher payment program, appointed by the commissioner;
- 8 (8) advocates for persons with disabilities,
- 9 including persons with mental illness and persons with mental
- 10 retardation, appointed by the commissioner; [and]
- 11 (9) providers of services to be provided under the
- voucher payment program, appointed by the commissioner;
- 13 (10) representatives of the Texas Workforce
- 14 Commission, appointed by the executive director of that commission;
- 15 and
- 16 (11) representatives of any other state agency as
- 17 considered necessary by the commissioner, appointed by the
- 18 governing body of their respective agency.
- 19 (g) This section expires September 1, 2007 [$\frac{2003}{2}$].
- 20 SECTION 3. The commissioner of health and human services
- 21 and the executive director of the Texas Workforce Commission shall
- 22 ensure that, not later than January 1, 2004, the composition of the
- 23 membership of the work group created to assist the Health and Human
- 24 Services Commission in implementing the voucher payment program
- 25 under Section 531.051, Government Code, complies with the
- 26 requirements of Section 531.052, Government Code, as amended by
- 27 this Act.
