SECTION 2. Section 8(g), Article 42.03, Code of Criminal 19 Procedure, as redesignated and amended by Section 1, Chapter 201, 20 21 Acts of the 73rd Legislature, Regular Session, 1993, is repealed. 22 SECTION 3. (a) This Act takes effect September 1, 2003. (b) The change in the law made by this Act applies only to 23 immunity from liability for an act or omission committed on or after 24

the effective date of this Act. An act or omission committed before the effective date of this Act is covered by the law in effect at the time the act or omission was committed, and the former law is continued in effect for that purpose.
