## A BILL TO BE ENTITLED

Τ	AN ACT
2	relating to the licensing and regulation of chiropractors.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subchapter E, Chapter 201, Occupations Code, is
5	amended by adding Section 201.206 to read as follows:
6	Sec. 201.206. CONFIDENTIALITY OF INVESTIGATION FILES. (a)
7	The board's investigation files are confidential, privileged, and
8	not subject to discovery, subpoena, or any other means of legal
9	compulsion for release other than to the board or an employee or
10	agent of the board.
11	(b) On request, the board may provide, at the completion of
12	an investigation, information contained in the investigation file
13	to the license holder under investigation. The board may share
14	information in investigation files with another state or federal
15	regulatory agency or with a local, state, or federal law
16	enforcement agency. The board is not required to disclose
17	information that is an attorney-client communication, an attorney
18	work product, or other information protected by a privilege
19	recognized by the Texas Rules of Civil Procedure or the Texas Rules
20	of Evidence.
21	(c) Notwithstanding Subsection (a), the board may:
22	(1) disclose a complaint to the affected license
23	holder; and

(2) provide to a complainant the license holder's

- 1 response to the complaint, if providing the response is considered
- 2 by the board to be necessary to investigate the complaint.
- 3 (d) This section does not prohibit the board or another party
- 4 <u>in a disciplinary action from offering into evidence in a contested</u>
- 5 case under Chapter 2001, Government Code, a record, document, or
- 6 other information obtained or created during an investigation.
- 7 SECTION 2. Section 201.355(a), Occupations Code, is amended
- 8 to read as follows:
- 9 (a) The board may renew without reexamination an expired
- 10 license of a person who was licensed in this state, moved to another
- 11 state or foreign country, and is currently licensed in good
- 12 standing and has been in practice in the other state or foreign
- 13 country for the two years preceding application.
- SECTION 3. Section 201.303(b), Occupations Code, is
- 15 repealed.
- SECTION 4. (a) This Act takes effect September 1, 2003.
- 17 (b) Section 201.206, Occupations Code, as added by this Act,
- 18 applies to a complaint or investigation pending on the effective
- 19 date of this Act or filed on or after that date.
- (c) The change in law made by this Act by the amendment of
- 21 Section 201.355(a), Occupations Code, applies only to an
- 22 application to renew a license filed on or after the effective date
- 23 of this Act. An application to renew a license filed before the
- 24 effective date of this Act is governed by the law in effect on the
- 25 date the application was filed, and the former law is continued in
- 26 effect for that purpose.
