- SECTION 1. Subsection (a), Section 352.002, Tax Code, 5

- 8 (9) a county that has a population of less than 12,000
- 9 and an area of less than 275 square miles;
- 10 (10) a county that has a population of 30,000 or less
- 11 and borders Possum Kingdom Lake;
- 12 (11) a county that borders the Republic of Mexico and
- has a population of more than 300,000 and less than 600,000;
- 14 (12) a county that has a population of 35,000 or more
- and borders or contains a portion of Lake Fork Reservoir;
- 16 (13) a county that borders the Republic of Mexico and
- in which there is located a national recreation area;

- 21 (15) a county that has a population of 28,000 or less,

- 4 SECTION 2. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2003.
