- SECTION 1. (a) Section 1301.002, Occupations Code, is amended by amending Subdivision (4) and adding Subdivision (1-a) to read as follows:
- 8 <u>(1-a) "Executive director" means the executive</u> 9 <u>director of the Texas State Board of Plumbing Examiners.</u>
  - (4) "Plumber's apprentice" means a person other than a master plumber, journeyman plumber, or tradesman plumber-limited license holder who, as the person's principal occupation, learns about and assists in the installation of plumbing, has fulfilled the requirements of and is registered by the board, and works under the supervision of a master plumber and the direct supervision of a licensed plumber.

- 23 SECTION 2. Section 1301.003, Occupations Code, is amended 24 to read as follows:

- 1 Sec. 1301.003. APPLICATION OF SUNSET ACT. The Texas State
- 2 Board of Plumbing Examiners is subject to Chapter 325, Government
- 3 Code (Texas Sunset Act). Unless continued in existence as provided
- 4 by that chapter, the board is abolished and this chapter expires
- 5 September 1, 2015 [2003].
- 6 SECTION 3. (a) Section 1301.052, Occupations Code, is
- 7 amended to read as follows:
- 8 Sec. 1301.052. WORK <u>INSIDE OR</u> OUTSIDE MUNICIPALITIES. A
- 9 person is not required to be licensed under this chapter to perform
- 10 plumbing, other than plumbing performed in conjunction with new

- 20 (d) A provisional license is valid until the date the board
- 21 approves or denies the provisional license holder's application for
- 22 <u>a license</u>. The board shall issue a license under this chapter to
- 23 the provisional license holder if:
- 24 (1) the provisional license holder is eligible to be
- 25 licensed under Subsection (a); or
- 26 (2) the provisional license holder passes the part of
- 27 the examination under Section 1301.352 that relates to the

- 1 applicant's knowledge and understanding of the laws and rules
- 2 relating to the practice of plumbing in this state and:
- 3 (A) the board verifies that the provisional

- 21 paying the required renewal fee to the <u>agency</u> [board] before the
- 22 expiration date of the license, endorsement, or registration.  $\underline{A}$
- 23 person whose license, endorsement, or registration has expired may
- 24 not engage in activities that require a license, endorsement, or

- 27 (b) A person whose license or endorsement has been expired

  20 has been expired for two years or more may not renew the license,
