## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to certain privacy protections for consumer information
- 3 included in the Texas no-call list.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 43.101, Business & Commerce Code, as
- 6 added by Chapter 1429, Acts of the 77th Legislature, Regular
- 7 Session, 2001, is amended to read as follows:
- 8 Sec. 43.101. COMMISSION TO ESTABLISH TEXAS NO-CALL LISTS.
- 9 (a) The commission shall establish and provide for the operation of
- 10 a database to compile a list of names[, addresses,] and telephone
- 11 numbers of consumers in this state who object to receiving
- 12 unsolicited telemarketing or telephone calls.
- 13 (b) The commission may contract with a private vendor to
- 14 maintain the Texas no-call list if:
- 15 (1) the private vendor has maintained a national
- 16 no-call list database for more than two years containing the names
- 17 [, addresses,] and telephone numbers of consumers in this state who
- 18 have previously requested to be added to the vendor's national
- 19 no-call list; and
- 20 (2) the contract requires the vendor to publish the
- 21 Texas portion of the national no-call list in an electronic format
- 22 to any telemarketer who agrees to use the Texas no-call list only
- 23 for the purposes of updating the no-call list of that telemarketer
- 24 by including in its list persons with whom the telemarketer does not

- 1 have an established business relationship.
- 2 The Texas no-call list must contain the name[ \_\_ address\_\_ ] and telephone numbers of each consumer in this state who has 3 4 requested to be on that list. The Texas no-call list shall be updated and published on January 1, April 1, July 1, and October 1 5 6 of each year. An entry on the Texas no-call list expires on the 7 third anniversary of the date the entry is first published on the 8 list. An entry may be renewed for successive three-year periods. 9 The telephone number of the consumer on the Texas no-call list may be deleted from the list on the consumer's written request or if the 10 telephone number of the consumer is changed. The commission may 11 charge a person a reasonable amount not to exceed \$3 for a request 12 to place a telephone number on the Texas no-call list established by 13 14 the commission or to renew an entry on the list. The commission 15 shall develop and make available a form to be used by customers to request to be on the Texas no-call list and shall provide a 16 17 toll-free telephone number and Internet mail address that persons may call or write to obtain a copy of the form. A private for-profit 18 publisher of a residential telephone directory that is distributed 19 to the public at minimal or no cost shall include in the directory a 20 prominently displayed toll-free number and Internet mail address 21 established by the commission through which a person may order a 22 23 copy of the form.
- SECTION 2. Subchapter C, Chapter 552, Government Code, is amended by adding Section 552.141 to read as follows:
- 26 <u>Sec. 552.141. EXCEPTION: TEXAS NO-CALL LIST. The Texas</u>
  27 no-call list created under Subchapter C, Chapter 43, Business &

- 1 Commerce Code, as added by Chapter 1429, Acts of the 77th
- 2 Legislature, Regular Session, 2001, is excepted from the
- 3 requirements of Section 552.021.
- 4 SECTION 3. The Public Utility Commission of Texas shall
- 5 adopt rules implementing the changes to the Texas no-call list and
- 6 shall delete consumer addresses from the Texas no-call list, as
- 7 required by this Act, before October 1, 2003.
- 8 SECTION 4. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2003.
