(a) A person may not misrepresent the geographical 8 location of a business that derives 50 percent or more of its gross 9 10 income from the sale or arranging for the sale of flowers or floral arrangements in the listing of the business in a telephone 11 12 directory or other directory assistance database. 13 (b) A person is considered to misrepresent the geographical 14 location of a business for purposes of Subsection (a) if the name of the business indicates that the business is located in a 15 geographical area and: 16 17 (1) the business is not located within geographical area indicated; 18 19 (2) the listing fails to identify the municipality and state of the business's geographical location; and 20 (3) a telephone call to the local telephone number 21

listed in the directory or database routinely is forwarded or

transferred to a location that is outside the calling area covered

by the directory or database in which the number is listed.

- 1 (c) A person may place a directory listing for a business
 2 described by Subsection (a) the name of which indicates that it is
 3 located in a geographical area that is different from the
 4 geographical area in which the business is located if a conspicuous
 5 notice in the listing states the municipality and state in which the
 6 business is located.
- 7 (d) This section does not apply to a publisher of a
 8 telephone directory or other publication or a provider of a
 9 directory assistance service publishing or providing information
 10 about another business.
- (e) This section creates no duty and imposes no obligation
 upon anyone other than the business that is the subject of the
 advertisement or listing.
- (f) A violation of this section is a false, misleading, or

 deceptive act or practice under this subchapter, and any public or

 private right or remedy prescribed by this subchapter may be used to

 enforce this section.

SECTION 2. This Act takes effect September 1, 2003, and applies only to a telephone directory published or directory assistance provided on or after that date. A telephone directory published or directory assistance provided before September 1, 2003, is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose.
