A BILL TO BE ENTITLED

AN ACT

2	relating to the Records Management Interagency Coordinating
3	Council.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 441.203, Government Code, is amended by
6	amending Subsections (a), (b), and (d)-(j) and adding Subsections
7	(a-1), $(a-2)$, $(a-3)$, and (k) to read as follows:
8	(a) The Records Management Interagency Coordinating Council
9	is composed of:
10	(1) permanent members, consisting of the following
11	officers or the officer's designee:
12	(A) [(1)] the secretary of state;
13	(B) [(2)] the state auditor, who serves as a
14	nonvoting member;
15	$\underline{(C)}$ [$\frac{(3)}{(3)}$] the comptroller of public accounts;
16	$\underline{(D)}$ [$\underline{(4)}$] the attorney general;
17	$\underline{\text{(E)}}$ [\(\frac{\(\frac{5}{2}\)}{\}\)] the director and librarian;
18	$\overline{\text{(F)}}$ [\frac{(6)}{}] the executive director of the <u>Texas</u>
19	Building and Procurement [General Services] Commission; and
20	$\underline{\text{(G)}}$ [$\frac{\text{(7)}}{\text{)}}$] the executive director of the
21	Department of Information Resources; and
22	(2) auxiliary voting members, consisting of:
23	(A) one faculty member of a public senior college
24	or university, as defined by Section 61.003, Education Code, who

- 1 has demonstrated knowledge of records and information management;
- 2 and
- 3 (B) two individuals who serve as information
- 4 resources managers, under Section 2054.071, for state agencies in
- 5 the executive branch of government.
- 6 (a-1) The presiding officer of the council shall appoint
- 7 auxiliary voting members in accordance with this section. To be
- 8 appointed by the presiding officer as an auxiliary voting member
- 9 for a full or partial term, a person must be nominated by the
- 10 presiding officer and receive the approval of a majority of the
- 11 permanent members listed under Subsection (a)(1).
- 12 (a-2) Auxiliary voting members serve two-year terms, with
- 13 the terms expiring February 1 of each odd-numbered year. A person
- 14 who is appointed as an auxiliary voting member or to fill a vacancy
- of an auxiliary voting member may continue to serve as a member only
- 16 while the person continues to possess the qualifications for the
- 17 category under which the person is appointed.
- 18 <u>(a-3)</u> The presiding officer shall fill a vacancy of an
- 19 auxiliary voting member for the unexpired term by appointing a
- 20 person who has the qualifications required under Subsection (a)(2)
- 21 for the vacated position. A person appointed to fill a vacant
- 22 position of an auxiliary voting member shall serve for the
- 23 <u>unexpired portion of the term for which the person is appointed.</u>
- 24 (b) The position of presiding officer rotates among the
- 25 <u>permanent</u> members of the council according to the procedures
- 26 adopted by the council. A term as presiding officer is two years
- and expires on February 1 of each odd-numbered year.

- 1 (d) The council's <u>permanent</u> member agencies shall provide
- 2 the staff for the council.
- 3 (e) The council shall:
- 4 (1) review the activities of each <u>permanent</u> member 5 agency that affect the state's management of records;
- 6 (2) study other records management issues; and
- 7 (3) report its findings and any recommended 8 legislation to the governor and the legislature not later than 9 November 1 of each even-numbered year.
- (f) The council shall adopt policies that coordinate the activities of each <u>permanent</u> member agency and that make other improvements in the state's management of records. The council shall adopt policies under this subsection using the rulemaking procedures prescribed by Chapter 2001.
- 15 (g) Each <u>permanent</u> member agency shall adopt the policies
 16 adopted under Subsection (f) as the <u>permanent</u> member agency's own
 17 rules, except to the extent that the policies conflict with other
 18 state or federal law.
- 19 (h) Each <u>permanent</u> member agency shall report on the 20 agency's adoption and implementation of rules under Subsection (g) 21 to the council not later than October 1 of each even-numbered year.
- 22 (i) In this section, "permanent member agency" means each 23 state officer who is a permanent member of the council or an agency 24 that has a representative who is a permanent member of the council.
- (j) The council shall categorize state agency programs and telephone numbers by subject matter as well as by agency. The council shall cooperate with the Texas Information and Referral

- 1 Network under Section 531.0312 to ensure that the council and the
- 2 network use a single method of defining and organizing information
- 3 about health and human services [. State agencies shall cooperate
- 4 with the council by providing the council with the information it
- 5 needs to perform this function].
- 6 (k) A state agency shall cooperate with the council in the
- 7 performance of its duties.
- 8 SECTION 2. The presiding officer of the Records Management
- 9 Interagency Coordinating Council shall make the initial
- 10 appointments of the auxiliary voting members of the council, in
- 11 accordance with Section 441.203, Government Code, as amended by
- 12 this Act, not later than October 31, 2003, for terms to expire
- 13 February 1, 2005.
- SECTION 3. This Act takes effect September 1, 2003.
