4	SECTION 1. Subchapter A, Chapter 161, Health and Safety
5	Code, is amended by adding Sections 161.010 and 161.0105 to read as

7	Sec. 161.010. INCREASE IMMUNIZATION AWARENESS. (a) The
8	department shall develop new public-private partnerships and work
9	with existing public-private partnership programs, including the
10	Seniors and Volunteers Program For Childhood Immunization, to
11	increase public and private awareness of and support for early
12	childhood immunizations.
13	(b) The department shall work with the Texas Education
14	Agency to increase immunization awareness and participation among
15	parents of preschool and school-age children by:
16	(1) jointly applying for federal funds for
17	immunization awareness and vaccination programs; and
18	(2) creating partnerships with public and private
19	health, service, and education organizations, including
20	parent-teacher associations, the United Way, schools, local
21	businesses, community-based organizations, chambers of commerce,
22	and athletic booster clubs, to increase awareness and participation
23	in the state's early childhood vaccination program.
24	Sec. 161.0105. LIMITATION ON LIABILITY. (a) A health care

1	provider who acts in compliance with Sections 161.007 and 161.008
2	and any rules adopted under those sections is not civilly or
3	criminally liable for furnishing the information required under
4	those sections. This subsection does not apply to criminal
5	liability established under Section 161.009.
6	(b) A person who administers a vaccination under a
7	department program may be held liable only to the extent the person
8	would be liable if the person administered the vaccination outside
9	the program. The person is not liable for damages arising from the
10	acts or omissions of another person acting under the program or the
11	department.
12	(c) The immunity created by this section is in addition to
13	any immunity created by Sections 161.001 and 161.007(g).
14	SECTION 2. Chapter 2056, Government Code, is amended by
15	adding Section 2056.0022 to read as follows:
16	Sec. 2056.0022. IMMUNIZATIONS AWARENESS. (a) Each state
17	agency that has contact with families in this state either in person
18	or by telephone, mail, or the Internet shall include in the agency's
19	strategic plan a strategy for increasing public awareness of the
20	need for early childhood immunizations.
21	(b) The Texas Department of Health shall identify the state
22	agencies to which this section applies and notify the agencies of
23	their duty under this section.
24	SECTION 3. This Act takes effect September 1, 2003.
