4 (1) on the physical premises of a school or 5 educational institution, any grounds or building on which an activity sponsored by a school or educational institution is being 6 conducted, or a passenger transportation vehicle of a school or 7 8 educational institution, whether the school or educational institution is public or private, unless pursuant to written 9 regulations or written authorization of the institution; 10

(2) on the premises of a polling place on the day of an 11 12 election or while early voting is in progress;

on the premises of [in] any government court or 13 (3) 14 offices utilized by the court, unless pursuant to written 15 regulations or written authorization of the court;

(5) in or into a secured area of an airport; or

within 1,000 feet of premises the location of 18 (6) which is designated by the Texas Department of Criminal Justice as a 19 place of execution under Article 43.19, Code of Criminal Procedure, 20 on a day that a sentence of death is set to be imposed on the 21 designated premises and the person received notice that: 22

going within 1,000 feet of the premises with 23 (A) 24 a weapon listed under this subsection was prohibited; or

25 possessing a weapon listed under (B) this subsection within 1,000 feet of the premises was prohibited. 26

SECTION 4. (a) This Act takes effect September 1, 2003.

1 (b) The change in law made by this Act applies only to an 2 offense committed on or after September 1, 2003. An offense 3 committed before September 1, 2003, is covered by the law in effect 4 when the offense was committed, and the former law is continued in 5 effect for that purpose. For purposes of this subsection, an 6 offense was committed before September 1, 2003, if any element of 7 the offense was committed before that date.
