3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subchapter A, Chapter 161, Health and Safety
5	Code, is amended by adding Sections 161.0095 and 161.0096 to read as
6	follows:
7	Sec. 161.0095. PHYSICIAN EDUCATION PROGRAMS. (a) The
8	department shall develop continuing education programs for
9	physicians relating to immunizations and the vaccines for children
10	program operated by the department under authority of 42 U.S.C.
11	Section 1396s, as amended. In developing the continuing education
12	programs and materials, the department shall consult with health
13	care providers.
14	(b) The department shall:
15	(1) offer education programs at health care provider
16	annual meetings; and
17	(2) use Texas Health Steps workers to assist the
18	department in providing the education programs.
19	Sec. 161.0096. PHYSICIAN EVALUATION. The department shall
20	administer an Assessment, Feedback, Incentives, and Exchange
21	evaluation program (AFIX) to assess immunization practices of
22	physicians, including physicians who provide immunizations to
23	children but who are not enrolled as participating providers in the
24	vaccines for children program operated by the department under the

- 2 SECTION 2. Subchapter B, Chapter 531, Government Code, is
- 3 amended by adding Section 531.063 to read as follows:
- 4 Sec. 531.063. VACCINES FOR CHILDREN PROGRAM PROVIDER
- 5 ENROLLMENT AND REIMBURSEMENT. (a) In this section, "vaccines for
- 6 children program" means the program operated by the Texas
- 7 Department of Health under authority of 42 U.S.C. Section 1396s, as
- 8 amended.
- 9 (b) The commission shall ensure that a provider can enroll
- in the vaccines for children program on the same form the provider
- 11 completes to apply as:
- 12 (1) a Medicaid health care provider; and
- 13 (2) a children's health insurance program health care
- 14 provider.
- 15 (c) The commission shall reimburse providers under Medicaid
- 16 and the children's health insurance program for vaccines
- 17 administered under the vaccines for children program at a rate that
- 18 covers the cost of administering the vaccines under the program.
- 19 SECTION 3. Not later than October 1, 2005, the Texas
- 20 Department of Health shall report to the legislature the results of
- 21 the educating physicians in your community pilot study operated by
- 22 the Texas Pediatric Society. The report shall include:
- 23 (1) an analysis of the program's effect on
- 24 immunization rates;
- 25 (2) a statement regarding the cost-effectiveness of
- 26 the program;
- 27 (3) recommendations for expanding the program; and

- 1 (4) a list of possible sources to fund the program.
- 2 SECTION 4. This Act takes effect September 1, 2003.
