- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subdivision (10), Section 271.111, Local
- 7 Government Code, is amended to read as follows:
- 8 (10) "Governmental entity" means a municipality,
- 9 county, [ex] river authority, or defense base development authority
- 10 established under Chapter 378 as added by Chapter 1221, Acts of the
- 11 76th Legislature, Regular Session, 1999.
- 12 SECTION 2. Subsections (a) and (d), Section 271.112, Local
- 13 Government Code, are amended to read as follows:
- 14 (a) Any provision in the charter of a home-rule municipality
- or [any] regulation, if any, of a county, [or] river authority, or
- 16 defense base development authority that requires the use of
- 17 competitive bidding or competitive sealed proposals or that
- 18 prescribes procurement procedures and that is in conflict with this
- 19 subchapter controls over this subchapter unless the governing body
- of the governmental entity elects to have this subchapter supersede
- 21 the charter or regulation.
- (d) For a contract entered into by a municipality, [or]
- 23 river authority, or defense base development authority under any of
- 24 the methods provided by this subchapter, the municipality, [or]

river authority, or defense base development authority shall 1 2 publish notice of the time and place the bids or proposals, or the 3 responses to a request for qualifications, will be received and The notice must be published in a newspaper of general 4 5 circulation in the county in which the defense base development authority's or municipality's central administrative office is 6 located or the county in which the greatest amount of the river 7 authority's territory is located once each week for at least two 8 9 weeks before the deadline for receiving bids, proposals, 10 responses. If there is not a newspaper of general circulation in 11 that county, the notice shall be published in a newspaper of general circulation in the county nearest the county seat of the county in 12 13 which the defense base development authority's or municipality's central administrative office is located or the county in which the 14 15 greatest amount of the river authority's territory is located. In a 16 two-step procurement process, the time and place the second step bids, proposals, or responses will be received are not required to 17 18 be published separately.

- 19 SECTION 3. (a) This Act takes effect September 1, 2003.
- 20 (b) The changes in law made by this Act apply only to a 21 contract for which requests for bids, requests for proposals, or 22 requests for qualifications are published or distributed on or 23 after September 1, 2003.
