5	SECTION 1. Section 615.021, Government Code, is amended by
6	amending Subsections (a) and (c) and adding Subsections (d) and (e)
7	to read as follows:
8	(a) A survivor of an individual listed under Section 615.003
9	is eligible for the payment of assistance under this chapter if:
10	(1) the listed individual died <u>as a result of a</u>
11	personal injury sustained in the line of duty [ <del>in the course of the</del>
12	individual's duty performed] in the individual's position as
13	described by Section 615.003 [ <del>as a result of exposure to a risk:</del>
14	[ <del>(A) that is inherent in the duty; or</del>
15	[ <del>(B) to which the general public is not</del>
16	<pre>customarily exposed]; and</pre>
17	(2) the survivor is:
18	(A) the surviving spouse of the listed
19	individual;
20	(B) a surviving child of the listed individual,
21	if there is no surviving spouse; or
22	(C) a surviving parent of the listed individual,
23	if there is no surviving spouse or child.
24	(c) An individual employed by the state or a political or

legal subdivision who is subject to certification by the Texas 1 Commission on Fire Protection or whose principal duties are 2 aircraft crash and rescue fire fighting is considered to have died 3 as a result of a personal injury sustained in the line of [in the 4 course of performing the individual's] duty in the individual's 5 position as described by Section 615.003 [as a result of exposure to 6 7 a risk that is inherent in the duty or to which the general public is 8 not customarily exposed] if the individual died while actually performing an activity that the individual was certified to perform 9 by the Texas Commission on Fire Protection, without regard to 10 whether the individual was actually performing the activity during 11 12 the individual's compensable hours at work.

13 (d) In a determination of whether the survivor of an 14 individual listed under Section 615.003 is eligible for the payment 15 of assistance under this chapter, any reasonable doubt arising from 16 the circumstances of the individual's death shall be resolved in 17 favor of the payment of assistance to the survivor.

(1) "Personal injury" means a traumatic injury or a
disease caused by or resulting from a traumatic injury.

21 (2) "Line of duty" means an action an individual 22 listed under Section 615.003 is required or authorized by rule, 23 condition of employment, or law to perform. The term includes an 24 action by the individual at a social, ceremonial, or athletic 25 function to which the individual is assigned by the individual's 26 employer.

SECTION 2. Section 811.001, Government Code, is amended by

1 amending Subdivision (12) and adding Subdivision (12-a) to read as 2 follows:

3 (12) "Occupational [death or] disability" means 4 [death or] disability from an injury or disease that directly 5 results from a specific act or occurrence determinable by a 6 definite time and place, and directly results from a risk or a 7 hazard peculiar to and inherent in a duty that arises from and in 8 the course of state employment.

9 <u>(12-a)</u> "Occupational death" means death from an injury 10 or disease that directly results from any action a person is 11 required or authorized by rule, condition of employment, or law to 12 perform. The term includes an action performed by the person at a 13 social, ceremonial, or athletic function to which the person is 14 assigned by the person's employer.

15 SECTION 3. The changes in law made by this Act to Sections 615.021 and 811.001, Government Code, relating to the death of 16 certain public servants apply only in relation to a death that 17 occurs on or after the effective date of this Act. 18 Matters regarding eligibility, payment, and benefits under Sections 19 615.021 and 811.001, Government Code, in relation to a death that 20 occurs before the effective date of this Act are governed by the law 21 in effect when the death occurs, and the former law is continued in 22 23 effect for that purpose.
