- 5 SECTION 1. Section 505.001, Occupations Code, is amended to

- 8 [Professional] Social Work Practice Act.
- 9 SECTION 2. Section 505.002, Occupations Code, is amended by

- 12 (3) "Council on Social Work Education" means the

- 16 (4-a) "Licensed baccalaureate social worker" means a
- 17 person who holds a baccalaureate social worker license issued by
- 18 the board under this chapter.
- 19 (4-b) "Licensed clinical social worker" means a person
- 20 who holds a clinical social worker license issued by the board under
- this chapter.
- SECTION 3. Subchapter A, Chapter 505, Occupations Code, is

- 9 International Classification of Diseases, and other diagnostic

- other activities by a person licensed under this chapter.
- 12 SECTION 4. Section 505.003, Occupations Code, is amended to

- 21 SECTION 5. Section 505.101(a), Occupations Code, is amended

- 24 consists of nine members appointed by the governor with the advice
- 25 and consent of the senate as follows:
- 26 (1) two [three] members who are licensed master social

- 11 benefit unless the person holds an appropriate license issued under
- 12 this chapter.
- 13 (b) A person may not use a title that implies that the person
- 14 holds a license in [professional] social work unless the person
- 15 holds an appropriate license issued under this chapter.
- 16 (c) A person who engages in or attempts to engage in conduct
- 17 described by this section is considered to be engaged in the
- 18 practice of [professional] social work.
- 19 SECTION 14. Section 505.353(b), Occupations Code, is
- 20 amended to read as follows:
- 21 (b) An applicant may take the licensing examination
- conducted by the board under Section 505.354 for:
- 23 (1) a master social worker license if the applicant
- 24 possesses a doctoral or master's degree in social work from a
- 25 graduate program accredited by the Council on Social Work
- 26 Education;
- 27 (2) a <u>baccalaureate</u> social worker license if the

- 1 applicant possesses a baccalaureate degree in social work from an
- 2 educational program accredited by the Council on Social Work
- 3 Education; or
