4	SECTION 1. Subchapter A, Chapter 8, Education Code, is

amended by adding Section 8.008 to read as follows:

- Sec. 8.008. APPLICABILITY OF CERTAIN LAWS RELATING TO

 POLITICAL ACTIVITIES. A regional education service center and each

 center employee is subject to Chapter 556, Government Code, and for
- 9 purposes of that chapter:
- 10 (1) the center is considered to be a state agency; and
- (2) each center employee is considered to be a state
- 12 <u>employee.</u>

- SECTION 2. Subchapter B, Chapter 8, Education Code, is amended by adding Section 8.056 to read as follows:
- SERVICES. A regional education service center that acts as a fiscal
 agent or broker in connection with an agreement between two school
 districts under Subchapter E, Chapter 41, may not, unless
 authorized in writing by the district receiving transferred funds
 in accordance with the agreement:
- 21 (1) be compensated by the districts in an amount that 22 exceeds the administrative cost of providing the service; or
- 23 (2) otherwise retain for use by the center any amount 24 other than the compensation permitted under Subdivision (1) from

1 the funds transferred between the districts in accordance with the

2 agreement.

- 3 SECTION 3. (a) After consulting with the presiding
- 4 officers of the standing committees in the senate and house of
- 5 representatives responsible for public education or with one or
- 6 more committee staff members designated for that purpose by the
- 7 appropriate presiding officer, the comptroller of public accounts
- 8 shall contract with a consultant for a comprehensive audit of
- 9 regional education service centers in this state. The audit must
- 10 include:
- 11 (1) a detailed analysis of all services provided by
- 12 regional education service centers that identifies, for each
- 13 service provided:
- 14 (A) the percentage of school districts receiving
- 15 the service;
- 16 (B) the costs to the regional education service
- 17 centers of providing the service;
- 18 (C) the charges imposed on school districts by
- 19 the regional education service centers for providing the service;
- 20 and
- 21 (D) the difference between the amount determined
- 22 under Paragraph (B) of this subdivision and the amount determined

- 24 (2) an evaluation of whether any services provided by
- 25 a regional education service center could be provided at a lower
- 26 cost by an alternative service provider, as determined based on a
- 27 survey of potential alternative service providers;

- 1 (3) an analysis of the governance structures of 2 regional education service centers;
- 3 (4) a review of the financial condition of regional
- 4 education service centers and their current funding sources to
- 5 determine the adequacy of state appropriations to regional
- 6 education service centers and whether those appropriations should
- 7 continue to be made;
- 8 (5) a review of the number and geographic distribution
- 9 of regional education service centers;
- 10 (6) a review of the institutional structure of
- 11 regional education service centers, with consideration of whether a
- 12 separate system of Texas Education Agency field offices would be
- 13 appropriate or whether any regional education service center
- 14 functions should be transferred to Texas Education Agency
- 15 facilities; and
- 16 (7) an analysis of the support functions of regional
- 17 education service centers to determine whether support
- 18 requirements could be decreased through business processes or
- 19 application redesigns.
- 20 (b) The comptroller of public accounts shall provide to the
- 21 presiding officers of the standing committees in the senate and
- 22 house of representatives responsible for public education written
- 23 notice of each meeting concerning the contract entered into under
- 24 Subsection (a) of this section or the audit described by Subsection
- 25 (a) of this section between the comptroller or staff members of the
- 26 comptroller's office and the person with whom the comptroller

- 1 presiding officer or one or more committee staff members designated
- 2 for that purpose by the appropriate presiding officer is entitled
- 3 to participate at each of those meetings.
- 4 (c) Costs of the audit required by Subsection (a) of this
- 5 section shall be paid using amounts appropriated for the fiscal
- 6 biennium ending August 31, 2005, to regional education service
- 7 centers or to the Texas Education Agency for the costs of services
- 8 provided by regional education service centers, not to exceed a
- 9 total amount of \$750,000.
- 10 (d) Not later than December 1, 2004, the comptroller of
- 11 public accounts shall submit a report to the legislature concerning
- 12 the results of the audit required by Subsection (a) of this section.
- 13 The report must include recommendations for a regional education
- 14 service center funding mechanism under which at least 80 percent of
- 15 center funds are derived from fee-for-service contracts with school
- 16 districts.
- SECTION 4. Effective September 1, 2005, Chapter 8,
- 18 Education Code, is repealed.
- 19 SECTION 5. Except as otherwise provided by this Act, this
- 20 Act takes effect September 1, 2003.
