A BILL TO BE ENTITLED

<u>L</u>	AN ACT

- 2 relating to use of regional notification centers to provide
- 3 underground facility notification before excavation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 251.009, Utilities Code, is amended to
- 6 read as follows:
- 7 Sec. 251.009. PROVISION OF GENERAL INFORMATION. At least
- 8 once each calendar year, at intervals not exceeding 15 months, each
- 9 Class A underground facility operator who conveys, transmits, or
- 10 distributes by means of its underground facilities service directly
- 11 to more than one million residential customers within this state
- 12 shall provide all of its residential customers in this state
- 13 general information about excavation activities covered by this
- 14 chapter and the appropriate [statewide] toll-free telephone number
- 15 established by the corporation.
- SECTION 2. Section 251.060, Utilities Code, is amended to
- 17 read as follows:
- Sec. 251.060. DUTIES OF CORPORATION. The corporation shall
- 19 develop and implement processes to:
- 20 (1) maintain a registration of:
- 21 (A) notification centers as provided by Section
- 22 251.101(a)(3);
- 23 (B) operators who elect to convert facilities to
- 24 Class A facilities under Section 251.005(a); or

- 1 (C) operators who elect to become Class A
- 2 underground facility operators under Section 251.005(b);
- 3 (2) establish minimum technical standards used by
- 4 notification centers;
- 5 (3) establish a statewide toll-free telephone number
- 6 to be used by excavators that incorporates the use of a call router
- 7 system that routes calls to the appropriate regional notification
- 8 center or establish a toll-free telephone number for each region
- 9 [centers on a pro rata basis];
- 10 (4) oversee the bid process and select the vendor for
- 11 the [statewide] toll-free telephone number or numbers;
- 12 (5) oversee the bid process and select the vendor for
- 13 the call router system, if necessary;
- 14 (6) determine before May 1 of each year, if necessary,
- 15 the cost-sharing between the notification centers of:
- 16 (A) the toll-free telephone number; and
- 17 (B) the call router system prescribed by Section
- 18 251.102(4);
- 19 (7) develop public service announcements to educate
- 20 the public about [statewide] one-call notification and its
- 21 availability;
- 22 (8) [establish a format for information transfer among
- 23 notification centers other than high speed data transmission, if
- 24 appropriate;
- 25 $\left[\frac{(9)}{}\right]$ on a complaint concerning charges, investigate
- 26 and determine appropriate charges;
- (9) $\left[\frac{(10)}{(10)}\right]$ recommend a civil penalty against a

- 1 notification center that does not meet the requirements of this
- 2 chapter of not less than \$1,000 or more than \$5,000 for each
- 3 violation;
- 4 (10) [(11)] refer the recommended penalty to the
- 5 attorney general, who shall institute a suit in a court of competent
- 6 jurisdiction to recover the penalty;
- 7 $\underline{(11)}$ [$\frac{(12)}{(12)}$] assist in dispute resolution among
- 8 notification centers or between a notification center and an
- 9 operator;
- 10 $\underline{(12)}$ [$\frac{(13)}{(13)}$] assist any operator who encounters
- 11 difficulty in joining the appropriate [a] notification center; and
- 12 (13) [(14)] review and study design standards for the
- 13 placement of underground facilities throughout this state.
- 14 SECTION 3. The heading to Section 251.061, Utilities Code,
- is amended to read as follows:
- 16 Sec. 251.061. CONTRACT FOR [STATEWIDE] TOLL-FREE NUMBER OR
- 17 NUMBERS AND CALL ROUTER SYSTEM.
- SECTION 4. Section 251.061(a), Utilities Code, is amended
- 19 to read as follows:
- 20 (a) The corporation shall solicit proposals for the
- 21 contract to establish and operate the [statewide] toll-free
- 22 telephone number or numbers and, if necessary, the call router
- 23 system by using a request for proposals process that includes
- 24 specifications that have been approved by the board of directors in
- 25 accordance with this chapter.
- SECTION 5. Subchapter C, Chapter 251, Utilities Code, is
- 27 amended by amending Sections 251.101 and 251.102 and by adding

- 1 Section 251.1015 to read as follows:
- 2 Sec. 251.101. NOTIFICATION CENTER. (a) A notification
- 3 center is a legal entity that:
- 4 (1) operates a notification system capable of serving
- 5 all excavators and operators in the system's region [statewide];
- 6 (2) is created to:
- 7 (A) receive notification of an intent to excavate
- 8 and of damage to an underground facility and disseminate that
- 9 information to member operators that may be affected by the
- 10 excavation or damage [and to other notification centers operating
- 11 in this state]; and
- 12 (B) receive notification of an extraordinary
- 13 circumstance and disseminate that information to member operators
- 14 [and to other notification centers operating in this state]; and
- 15 (3) registers the following information with the
- 16 corporation:
- 17 (A) its name, address, and telephone number;
- 18 (B) the name of a contact person;
- 19 (C) a statement of compliance with Section
- 20 251.104; and
- 21 (D) a listing of the counties in the system's
- 22 region [which it operates].
- (b) The three [A] notification centers [center] operating
- on September 1, 1997, may continue to operate if the notification
- 25 centers comply [center complies] with this chapter. A notification
- 26 center may operate only in the region to which the center is
- 27 assigned by Section 251.1015. If a notification center fails to

- 6 SECTION 6. Sections 251.107(a) and (b), Utilities Code, are
- 7 amended to read as follows:
- 8 (a) Each operator of a Class A underground facility,
- 9 including a political subdivision of this state, shall participate
- in the [a] notification center assigned to the region in which that
- 11 facility is located as a condition of doing business in this state.
- 12 (b) Each operator of a Class A underground facility shall
- 13 provide to the notification center assigned to the region in which
- 14 that facility is located:
- 15 (1) maps or grid locations or other identifiers
- 16 determined by the operator indicating the location of the
- 17 operator's underground facilities;
- 18 (2) the name and telephone number of a contact person
- 19 or persons; and
- 20 (3) at least quarterly but, if possible, as those
- 21 changes occur, information relating to each change in the
- 22 operator's maps or grid locations or other identifiers or in the
- 23 person or persons designated as the operator's contact person or
- 24 persons.
- 25 SECTION 7. Section 251.151(a), Utilities Code, is amended
- 26 to read as follows:
- 27 (a) Except as provided by Sections 251.155 and 251.156, a

- 1 person who intends to excavate shall notify $\underline{\text{the}}$ [$\underline{\textbf{a}}$] notification
- 2 center assigned to the region in which the excavation will occur not
- 3 earlier than the 14th day before the date the excavation is to begin
- 4 or later than the 48th hour before the time the excavation is to
- 5 begin, excluding Saturdays, Sundays, and legal holidays.
- 6 SECTION 8. Section 251.153, Utilities Code, is amended to
- 7 read as follows:
- 8 Sec. 251.153. DUTY OF NOTIFICATION CENTER. (a) At the time
- 9 an excavator provides the $[\frac{1}{4}]$ notification center with the
- 10 excavator's intent to excavate, the notification center shall
- 11 advise the excavator that water, slurry, and sewage underground
- 12 facilities in the area of the proposed excavation may not receive
- information concerning the excavator's proposed excavation.
- 14 (b) [Not later than two hours after the time th
- 15 notification center receives a notice of intent to excavate from an
- 16 excavator, the notification center shall provide to every other
- 17 affected notification center operating in this state the
- 18 information required by Section 251.152 and received from the
- 19 excavator. The notification center shall provide the information
- 20 by the use of high speed data transmission.
- 21 $\left[\frac{(c)}{c}\right]$ Not later than two hours after the time the
- 22 notification center receives a notice of intent to excavate from an
- 23 excavator [or from a different notification center], the
- 24 notification center shall notify each member operator that may have
- 25 an underground facility in the vicinity of the proposed excavation
- 26 operation.
- 27 SECTION 9. Section 251.154(a), Utilities Code, is amended

- 1 to read as follows:
- 2 (a) A person required to provide notice under this chapter
- 3 is considered to have provided the notice when the person delivers
- 4 the required information and the appropriate [a] notification
- 5 center receives that information within the time limits prescribed
- 6 by this chapter.
- 7 SECTION 10. Section 251.155(c), Utilities Code, is amended
- 8 to read as follows:
- 9 (c) When an emergency exists, the excavator shall notify the
- 10 <u>appropriate</u> [a] notification center as promptly as reasonably
- 11 possible.
- 12 SECTION 11. Section 251.158(b), Utilities Code, is amended
- 13 to read as follows:
- (b) The operator shall notify the appropriate [a]
- 15 notification center of the extraordinary circumstance and shall
- 16 include in the notification:
- 17 (1) the nature and location of the extraordinary
- 18 circumstance;
- 19 (2) the expected duration of the situation and the
- 20 approximate time at which the operator will be able to resume
- 21 location request activities; and
- 22 (3) the name and telephone number of the individual
- 23 that the notification system can contact if there is an emergency
- that requires the operator's immediate attention.
- 25 SECTION 12. Section 251.159(b), Utilities Code, is amended
- 26 to read as follows:
- 27 (b) If the excavator is not certain of the operator's

- 1 identity, the excavator shall contact the appropriate [a]
- 2 notification center to report the damage[, and the notification
- 3 center shall immediately notify all other affected notification
- 4 centers]. Immediately on receiving notification, each
- 5 notification center shall contact each member operator that has
- 6 underground facilities in or near the area in which the damage
- 7 occurred.
- 8 SECTION 13. Section 251.202(c), Utilities Code, is amended
- 9 to read as follows:
- 10 (c) The corporation shall use the money received under this
- 11 section to develop public service announcements to educate the
- 12 public about [the statewide] one-call notification system and its
- availability as prescribed by Section 251.060(7).
- SECTION 14. Section 251.105(a), Utilities Code, is
- 15 repealed.
- SECTION 15. (a) This Act takes effect September 1, 2003.
- 17 (b) The Texas Underground Facility Notification Corporation
- 18 shall implement the regional notification system as required by
- 19 this Act not later than January 1, 2004. In implementing the
- 20 system, the corporation shall ensure that a contract described by
- 21 Subsection (c) of this section is not impaired.
- (c) This Act does not affect the validity of a contract
- 23 between a notification center and an operator that was entered into
- 24 before the effective date of this Act. An operator that enters into
- 25 a contract with a notification center before the effective date of
- 26 this Act shall comply with Section 251.107(a), Utilities Code, as
- amended by this Act, on expiration of the contract.
