- 7 (1) "Caseworker" means a full-time employee who is a

- 9 (2) "Department" means the Department of Protective
- 10 and Regulatory Services.
- 11 (3) "Target region" means a department service region
- in which the department, before September 1, 2003, implemented a
- 13 pilot project under Chapter 607, Acts of the 77th Legislature,
- 14 Regular Session, 2001, and subsequently terminated the pilot
- 15 project after successfully reducing vacancies in authorized
- 16 caseworker positions in that service region.
- 17 (4) "Target training academy" means a training academy
- 18 that trains caseworkers for the department and that is located in a
- 19 target region.
- 20 SECTION 2. PILOT PROJECT. Subject to available funding,
- 21 the department shall implement a pilot project to assist a target
- 22 region in continuing to accomplish the goals of the pilot project
- 23 under Chapter 607, Acts of the 77th Legislature, Regular Session,
- 24 2001.

- 1 SECTION 3. DEPARTMENT DUTIES. In implementing the pilot
- 2 project under this Act, the department shall:
- 3 (1) remove the limit on the number of authorized
- 4 caseworker positions in a target region;
- 5 (2) increase the number of trainee positions in a
- 6 target training academy to a total that is 140 percent of the number
- 7 of trainee positions immediately before September 1, 2003;
- 8 (3) maintain the number of trainers and other
- 9 necessary training academy positions in a target training academy
- 10 at the level necessary to accomplish the purposes of Subdivision
- 11 (2) of this section; and
- 12 (4) provide available funds as necessary to accomplish
- the purposes of Subdivisions (1), (2), and (3) of this section.
- SECTION 4. REPORT. Not later than December 31, 2004, the
- department shall submit a report to the legislature regarding the
- 16 effect of the pilot project under this Act on the retention of
- 17 caseworkers in each target region in which the pilot project under
- 18 this Act is implemented. The report must include an assessment of
- 19 the continuing need for the pilot project and a recommendation on
- 20 whether the project should be continued. The legislature shall
- 21 consider the report in considering additional legislation to
- 22 address the need of certain regions of the state for child
- 23 protective services caseworkers.
- 24 SECTION 5. EFFECTIVE DATE. This Act takes effect September
- 25 1, 2003.
- SECTION 6. EXPIRATION DATE. This Act expires September 1,
