4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 301, Labor Code, is amended by adding
6	Subchapter I to read as follows:

SUBCHAPTER I. ADULT EDUCATION AND LITERACY

- 8 Sec. 301.151. COOPERATION WITH TEXAS EDUCATION AGENCY TO
 9 IMPROVE ADULT EDUCATION AND LITERACY SERVICES. The commission
 10 shall collaborate with the Texas Education Agency to improve the
 11 coordination and implementation of adult education and literacy
 12 services in this state.
- SEC. 301.152. DEVELOPMENT OF WORKPLACE LITERACY AND BASIC

 SKILLS CURRICULUM. (a) Under contract with the Texas Education

 Agency, the commission shall develop a demand-driven workplace

 literacy and basic skills curriculum aimed at assisting local

 workforce development boards to equip workers and job seekers with

 the skills necessary to compete for current and emerging jobs in

 this state.
- 20 <u>(b) In developing the general curriculum required by</u>
 21 Subsection (a), the commission shall:
- (1) evaluate existing efforts and potential cost savings resulting from designing specific curricula that address the needs of various industry sectors in the business community;

2	of workers, employers, providers, and local workforce development

4	(3) target up to five industry sectors in the business

- 6 SECTION 3. Section 29.252, Education Code, is amended by
- 7 amending Subsection (a) and adding Subsection (a-1) to read as
- 8 follows:
- 9 (a) The agency shall:
- 10 (1) provide adequate staffing to develop, administer,
- 11 and support a comprehensive statewide adult education program and
- 12 coordinate related federal and state programs for education and
- 13 training of adults;
- 14 (2) develop, implement, and regulate a comprehensive
- 15 statewide program for community level education services to meet
- 16 the special needs of adults;
- 17 (3) develop the mechanism and guidelines for
- 18 coordination of comprehensive adult education and related skill
- 19 training services for adults with other agencies, both public and
- 20 private, in planning, developing, and implementing related
- 21 programs, including community education programs;
- 22 (4) administer all state and federal funds for adult
- 23 education and related skill training in this state, except in
- 24 programs for which another entity is specifically authorized to do
- 25 so under other law;
- 26 (5) prescribe and administer standards and
- 27 accrediting policies for adult education;

- 1 (6) prescribe and administer rules for teacher
- 2 certification for adult education;
- 3 (7) accept and administer grants, gifts, services, and
- 4 funds from available sources for use in adult education; [and]
- 5 (8) adopt or develop and administer a standardized
- 6 assessment mechanism for assessing all adult education program
- 7 participants who need literacy instruction, adult basic education,
- 8 or secondary education leading to an adult high school diploma or
- 9 the equivalent;
- 10 (9) collaborate with the Texas Workforce Commission to
- improve the coordination and implementation of adult education and
- 12 <u>literacy services in this state; and</u>
- 13 (10) monitor and evaluate educational and employment
- 14 outcomes of students who participate in the agency's adult
- 15 <u>education and literacy programs.</u>
- 16 (a-1) The agency shall use existing federal funds to
- 17 contract with the Texas Workforce Commission for the development of
- 18 a demand-driven workplace literacy and basic skills curriculum that
- 19 complies with the requirements adopted under Section 301.152, Labor
- 20 Code. This subsection expires September 1, 2005.
- 21 SECTION 4. The Texas Workforce Commission shall implement
- 22 Section 301.151, Labor Code, as added by this Act, as soon as
- 23 possible after the effective date of this Act.
- 24 SECTION 5. The Texas Workforce Commission shall implement
- 25 Section 301.152, Labor Code, as added by this Act, not later than
- 26 February 1, 2004.
- 27 SECTION 6. The Texas Education Agency shall implement

- 1 Section 29.252(a), Education Code, as amended by this Act, and
- 2 Section 29.252(a-1), Education Code, as added by this Act, as soon
- 3 as possible after the effective date of this Act.
- 4 SECTION 7. This Act takes effect September 1, 2003.
