7	CHAPTER 173. TEMPORARY SALARY PAYMENTS FOR MUNICIPAL

9	Sec. 173.001. EMPLOYEES SUBJECT TO CHAPTER. (a) This
10	chapter applies to a municipal or county employee who is a member of
11	a reserve component of the armed forces of the United States,
12	including any appropriate part of the state military forces, and
13	who by virtue of that membership is called to active duty in the
14	armed forces of the United States by federal authority without the
15	person's consent before, on, or after the effective date of this
16	chapter as part of a partial or total mobilization of the reserve
17	components of the armed forces.
18	(b) This chapter does not apply to a person who:
19	(1) ceases to be employed by a municipality or county
20	because the person resigns or is terminated for a reason that is not
21	a direct consequence of the person's call to active duty as

described under Subsection (a); or

- Sec. 173.002. SALARY CONTINUATION. (a) Notwithstanding 1 2 any other law, if a person to whom this chapter applies exhausts all 3 military leave to which the person is entitled under state law, the 4 municipality or county may continue the person's municipal or county salary payments under this chapter in an amount determined 5 6 by the governing body of the municipality or the commissioners court, as applicable, until the person is no longer required to 7 serve on active duty under the circumstances described by Section 8
- 10 <u>(b) The salary payments authorized by Subsection (a) are</u>

- (1) from the general fund of the municipality or

  county or other funds available for that purpose on the date the

  person is called to active duty; and

- Sec. 173.003. MANNER OF PAYMENT. Salary payments under this chapter may be paid in the manner directed by the person, except as provided by other law.
- Sec. 173.004. RULES. The governing body of a municipality
  and the commissioners court of a county may adopt rules to implement
  this chapter.
- Sec. 173.005. OTHER BENEFITS UNAFFECTED. This chapter only authorizes the continuation of municipal or county salary payments as provided by Sections 173.001-173.004.
- Sec. 173.006. EXPIRATION OF CHAPTER. This chapter expires

  September 1, 2005.

SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2003.
