8	part of a full investigation of a complaint alleging financial
9	misconduct conducted under Section 33.022, the commission may
10	conduct an audit of the assets, financial records, and financial
11	situation of the judge against whom the complaint was made.
12	(b) An audit may be conducted under this section only if,
13	after conducting a preliminary investigation under Section 33.022,
14	a majority of the members of the commission:
15	(1) have a reasonable belief that the judge against
16	whom the complaint was filed engaged in wilful or persistent
17	conduct that is clearly inconsistent with the proper performance of
18	a judge's duties; and
19	(2) vote in favor of an audit.
20	(c) The commission may contract with a licensed auditor to
21	conduct an audit under this section.
22	(d) An audit must be conducted in accordance with generally
23	accepted auditing standards as prescribed by the American Institute
24	of Certified Public Accountants, the Governmental Accounting

Standards Board, the United States General Accounting Office, or 1 2 other professionally recognized entities that prescribe auditing 3 standards. 4 SECTION 2. Section 33.031, Government Code, is amended to 5 read as follows: 6 Sec. 33.031. [NO AWARD OF] COSTS, FEES, AND EXPENSES. <u>(</u>a) Except as provided by Subsection (b), court [Court] costs or 7 attorney's fees may not be awarded in a proceeding under this 8 9 chapter. (b) On a finding of misconduct of a judge in formal 10 proceedings before a special master or the commission that results 11 12 from a complaint alleging financial misconduct, the commission is entitled to recover from the judge court costs, attorney's fees, 13 14 and reasonable expenses related to the proceedings. 15 SECTION 3. (a) Section 33.0225, Government Code, as added by this Act, applies only to the investigation of a complaint 16 17 received by the State Commission on Judicial Conduct on or after the effective date of this Act. The investigation of a complaint 18 received before the effective date of this Act is governed by the 19 law in effect on the date the complaint was received, and the former 20 law is continued in effect for that purpose.

(b) Section 33.031, Government Code, as amended by this Act, 22 applies only to formal proceedings instituted on or after the 23 effective date of this Act. Formal proceedings instituted before 24 25 the effective date of this Act are governed by the law in effect at the time the proceedings were instituted, and the former law is 26 continued in effect for that purpose. 27
