4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 402.001, Local Government Code, is
6	amended by adding Subsections (e) and (f) to read as follows:
7	(e) A municipality each year may by ordinance add a fee,
8	covering a period not to exceed one year, to the utility bill issued
9	by a municipally owned utility system containing one or more
10	utilities. The fee:
11	(1) may not exceed \$1 each month;
12	(2) shall be paid at an interval determined by the
13	governing body of the municipality; and
14	(3) shall be described on the bill as "city ADA fee."
15	(f) The municipality shall deposit in a special account the
16	fees collected under Subsection (e). Funds in the account may be
17	used only by the municipality to comply with the Americans with
18	Disabilities Act of 1990 (42 U.S.C. Section 12101 et seq.), as
19	amended, in providing:
20	(1) construction and maintenance of accessible street
21	and sidewalk improvements, including curb cuts and auditory alarms
22	at crosswalks; and
23	(2) construction and maintenance of accessible
24	municipal parks and municipal park improvements.

1 SECTION 2. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2003.
