1 AN ACT 2 relating to local school health advisory councils, health education 3 instruction, and coordinated health programs for elementary school 4 students. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. The heading to Section 28.004, Education Code, is amended to read as follows: 7 Sec. 28.004. LOCAL SCHOOL HEALTH ADVISORY 8 [EDUCATION] COUNCIL AND HEALTH EDUCATION INSTRUCTION. 9 SECTION 2. Section 28.004, Education Code, is amended by 10 amending Subsections (a) through (e) and adding Subsection (k) to 11 12 read as follows: 13 (a) The board of trustees of each school district shall 14 establish a local school health [education] advisory council to 15 assist the district in ensuring that local community values are reflected in the district's health education instruction. 16 (b) A school district must consider the recommendations of 17 the local school health [education] advisory council before 18 changing the district's health education curriculum 19 or instruction. 20 The local school health [education] advisory council's (c) 21 22 duties include recommending: 23 (1) the number of hours of instruction to be provided in health education; 24

1 (2) [health education] curriculum appropriate for specific grade levels [that may include a coordinated health 2 education program] designed to prevent obesity, cardiovascular 3 disease, and Type 2 [II] diabetes through coordination of: 4 5 (A) health education; (B) physical education and physical activity; 6 7 (C) nutrition [nutritional] services; (D) parental involvement; and 8 9 (E) instruction to prevent the use of tobacco; 10 [and] 11 (3) appropriate grade levels and methods of instruction for human sexuality instruction; and 12 13 (4) strategies for integrating the curriculum components specified by Subdivision (2) with the following elements 14 15 in a coordinated school health program for the district: 16 (A) school health services; 17 (B) counseling and guidance services; 18 (C) a safe and healthy school environment; and (D) school employee wellness. 19 The board of trustees shall appoint members to the local 20 (d) school health [education] advisory council. A majority of the 21 members must be persons who are parents of students enrolled in the 22 district and who are not employed by the district. The board of 23 trustees also may appoint one or more persons from each of the 24

No. 1357 public school administrators; 1 (2) 2 (3) district students; 3 health care professionals; (4) 4 (5) the business community; (6) law enforcement; 5 (7) senior citizens; 6 7 (8) the clergy; and nonprofit health organizations. 8 (9) 9 (e) Any course materials and instruction relating to human sexuality, transmitted 10 sexually diseases, or human immunodeficiency virus or acquired immune deficiency syndrome 11 shall be selected by the board of trustees with the advice of the 12 local school health [education] advisory council and must: 13 (1) present abstinence from sexual activity as the 14 15 preferred choice of behavior in relationship to all sexual activity 16 for unmarried persons of school age; 17 (2) devote more attention to abstinence from sexual 18 activity than to any other behavior; emphasize that abstinence from sexual activity, if (3) 19 used consistently and correctly, is the only method that is 100 20 percent effective in preventing pregnancy, sexually transmitted 21 22 diseases, infection with human immunodeficiency virus or acquired immune deficiency syndrome, and the emotional trauma associated 23 24 with adolescent sexual activity; 25 (4) direct adolescents to a standard of behavior in which abstinence from sexual activity before marriage is the most 26

effective way to prevent pregnancy, sexually transmitted diseases,

1 and infection with human immunodeficiency virus or acquired immune 2 deficiency syndrome; and

3 (5) teach contraception and condom use in terms of 4 human use reality rates instead of theoretical laboratory rates, if 5 instruction on contraception and condoms is included in curriculum 6 content.

7 (k) A school district shall make available for reasonable
8 public inspection:

9 <u>(1) a statement of the policies adopted to ensure that</u> 10 <u>students in elementary grades engage in at least 30 minutes per</u> 11 <u>school day or 135 minutes per school week of physical activity; and</u> 12 <u>(2) a statement of:</u>

13 (A) the number of times during the year the 14 district's school health advisory council has met;

15 <u>(B) whether the district has adopted and enforces</u> 16 policies to ensure that district campuses comply with agency 17 vending machine and food service guidelines for restricting student 18 access to vending machines; and

19 (C) whether the district has adopted and enforces 20 policies and procedures that prescribe penalties for the use of 21 tobacco products by students and others on school campuses or at 22 school-sponsored or school-related activities.

23 SECTION 3. Section 38.013, Education Code, as added by 24 Chapter 907, Acts of the 77th Legislature, Regular Session, 2001, 25 is amended to read as follows:

26 Sec. 38.013. COORDINATED HEALTH PROGRAM FOR ELEMENTARY 27 SCHOOL STUDENTS. (a) The agency shall make available to each

1 school district <u>one or more</u> [a] coordinated health <u>programs</u>
2 [program] designed to prevent obesity, cardiovascular disease, and
3 Type <u>2</u> [II] diabetes in elementary school students. <u>Each</u> [The]

9 (a-1) The commissioner by rule shall adopt criteria for 10 evaluating a coordinated health program before making the program available under Subsection (a). Before adopting the criteria, the 11 commissioner shall request review and comment concerning the 12 criteria from the Texas Department of Health's School Health 13 Advisory Committee. The commissioner may make available under 14 15 Subsection (a) only those programs that meet criteria adopted under 16 this subsection.

17 (b) The agency shall notify each school district of the
18 availability of the programs [program].
