## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the authority of a guardian of the person of a ward to
3	transport the ward to an inpatient mental health facility and file
4	for emergency detention under certain circumstances and to consent
5	to the administration of certain medication.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subsection (b), Section 743, Texas Probate Code,
8	is amended to read as follows:
9	(b) The guardian of the person, whether or not there is a
10	separate guardian of the estate, shall submit to the court an annual
11	report by sworn affidavit that contains the following information:
12	(1) the guardian's current name, address, and phone
13	number;
14	(2) the ward's current:
15	(A) name, address, and phone number; and
16	(B) age and date of birth;
17	(3) the type of home in which the ward resides,
18	described as the ward's own; a nursing, guardian's, foster, or
19	boarding home; a relative's home, and the ward's relationship to the
20	relative; a hospital or medical facility; or other type of
21	residence;
22	(4) the length of time the ward has resided in the

present home and, if there has been a change in the ward's residence

in the past year, the reason for the change;

- 1 (5) the date the guardian most recently saw the ward,
- 2 and how frequently the guardian has seen the ward in the past year;
- 3 (6) a statement indicating whether or not the guardian
- 4 has possession or control of the ward's estate;
- 5 (7) the following statements concerning the ward's
- 6 health during the past year:
- 7 (A) whether the ward's mental health has
- 8 improved, deteriorated, or remained unchanged, and a description if
- 9 there has been a change; and
- 10 (B) whether the ward's physical health has
- improved, deteriorated, or remained unchanged, and a description if
- 12 there has been a change;
- 13 (8) a statement concerning whether or not the ward has
- 14 regular medical care, and the ward's treatment or evaluation by any
- of the following persons during the last year, including the name of
- 16 that person, and the treatment involved:
- 17 (A) a physician;
- 18 (B) a psychiatrist, psychologist, or other
- 19 mental health care provider;
- 20 (C) a dentist;
- 21 (D) a social or other caseworker; or
- 22 (E) another individual who provided treatment;
- 23 (9) a description of the ward's activities during the
- 24 past year, including recreational, educational, social, and
- 25 occupational activities, or if no activities are available or if
- 26 the ward is unable or has refused to participate in them, a
- 27 statement to that effect;

- 1 (10) the guardian's evaluation of the ward's living
- 2 arrangements as excellent, average, or below average, including an
- 3 explanation if the conditions are below average;
- 4 (11) the guardian's evaluation of whether the ward is
- 5 content or unhappy with the ward's living arrangements;
- 6 (12) the guardian's evaluation of unmet needs of the
- 7 ward;
- 8 (13) a statement of whether or not the guardian's power
- 9 should be increased, decreased, or unaltered, including an
- 10 explanation if a change is recommended;
- 11 (14) a statement that the guardian has paid the bond
- 12 premium for the next reporting period; and
- 13 (15) any additional information the guardian desires
- 14 to share with the court regarding the ward, including whether the
- 15 guardian has filed for emergency detention of the ward under
- 16 Subchapter A, Chapter 573, Health and Safety Code, and if
- applicable, the number of times the guardian has filed and the dates
- 18 of the applications.
- 19 SECTION 2. Section 767, Texas Probate Code, is amended to
- 20 read as follows:
- Sec. 767. POWERS AND DUTIES OF GUARDIANS OF THE PERSON.
- 22 <u>(a)</u> The guardian of the person is entitled to the charge and
- 23 control of the person of the ward, and the duties of the guardian
- 24 correspond with the rights of the guardian. A guardian of the
- 25 person has:
- 26 (1) the right to have physical possession of the ward
- 27 and to establish the ward's legal domicile;

- 1 (2) the duty of care, control, and protection of the
- 2 ward;
- 3 (3) the duty to provide the ward with clothing, food,
- 4 medical care, and shelter; and
- 5 (4) the power to consent to medical, psychiatric, and
- 6 surgical treatment other than the in-patient psychiatric
- 7 commitment of the ward.
- 8 (b) Notwithstanding Subsection (a)(4) of this section, a
- 9 guardian of the person of a ward has the power to transport the ward
- 10 to an inpatient mental health facility for a preliminary
- 11 examination in accordance with Subchapters A and C, Chapter 573,
- 12 <u>Health and Safety Code</u>.
- SECTION 3. Subsection (b), Section 770, Texas Probate Code,
- is amended to read as follows:
- 15 (b) Except as provided by Subsection (c) or (d) of this
- 16 section, a guardian may not voluntarily admit an incapacitated
- 17 person to a public or private in-patient psychiatric facility or to
- 18 a residential facility operated by the Texas Department of Mental
- 19 Health and Mental Retardation for care and treatment. If care and
- treatment in a psychiatric or a residential facility are necessary,
- 21 the person or the person's guardian may:
- 22 <u>(1)</u> apply for services under Section 593.027 or
- 23 593.028, Health and Safety Code;
- (2) (2) [ $\frac{}{7}$  or ] apply to a court to commit the person under
- 25 Subtitle D, Title 7, Health and Safety Code (Persons with Mental
- 26 Retardation Act), Subtitle C, Title 7, Health and Safety Code
- 27 (Texas Mental Health Code), or Chapter 462, Health and Safety Code;

- 1 <u>or</u>
- 2 (3) transport the ward to an inpatient mental health
- 3 facility for a preliminary examination in accordance with
- 4 Subchapters A and C, Chapter 573, Health and Safety Code.
- 5 SECTION 4. Subpart E, Part 4, Chapter XIII, Texas Probate
- 6 Code, is amended by adding Section 770A to read as follows:
- 7 Sec. 770A. ADMINISTRATION OF MEDICATION. (a) In this
- 8 section, "psychoactive medication" has the meaning assigned by
- 9 Section 574.101, Health and Safety Code.
- 10 (b) If a person under a protective custody order as provided
- 11 by Subchapter B, Chapter 574, Health and Safety Code, is a ward who
- is not a minor, the guardian of the person of the ward may consent to
- 13 the administration of psychoactive medication as prescribed by the
- 14 ward's treating physician regardless of the ward's expressed
- 15 preferences regarding treatment with psychoactive medication.
- 16 SECTION 5. The heading of Subchapter A, Chapter 573, Health
- and Safety Code, is amended to read as follows:
- SUBCHAPTER A. APPREHENSION BY PEACE OFFICER
- OR TRANSPORTATION FOR EMERGENCY DETENTION BY GUARDIAN
- SECTION 6. Subchapter A, Chapter 573, Health and Safety
- 21 Code, is amended by adding Sections 573.003 and 573.004 to read as
- 22 follows:
- Sec. 573.003. TRANSPORTATION FOR EMERGENCY DETENTION BY
- 24 GUARDIAN. (a) A guardian of the person of a ward who is 18 years of
- 25 age or older, without the assistance of a peace officer, may
- 26 transport the ward to an inpatient mental health facility for a
- 27 preliminary examination in accordance with Section 573.021 if the

guardian has reason to believe and does believe that: 1 2 (1) the ward is mentally ill; and 3 (2) because of that mental illness there is a substantial risk of serious harm to the ward or to others unless the 4 ward is immediately restrained. 5 (b) A substantial risk of serious harm to the ward or others 6 7 under Subsection (a)(2) may be demonstrated by: 8 (1) the ward's behavior; or (2) evidence of severe emotional distress and 9 10 deterioration in the ward's mental condition to the extent that the 11 ward cannot remain at liberty. Sec. 573.004. GUARDIAN'S APPLICATION FOR EMERGENCY 12 13 DETENTION. (a) After transporting a ward to a facility under Section 573.003, a guardian shall immediately file an application 14 15 for detention with the facility. 16 (b) The application for detention must contain: 17 (1) a statement that the guardian has reason to 18 believe and does believe that the ward evidences mental illness; (2) a statement that the guardian has reason to 19 20 believe and does believe that the ward evidences a substantial risk of serious harm to the ward or others; 21 22 (3) a specific description of the risk of harm; (4) a statement that the guardian has reason to 23 believe and does believe that the risk of harm is imminent unless 24 25 the ward is immediately restrained;

derived from specific recent behavior, overt acts, attempts, or

(5) a statement that the guardian's beliefs are

- 1 threats that were observed by the guardian; and
- 2 (6) a detailed description of the specific behavior,
- 3 acts, attempts, or threats.
- 4 (c) The guardian shall immediately provide written notice
- 5 of the filing of an application under this section to the court that
- 6 granted the guardianship.
- 7 SECTION 7. Subsection (c), Section 573.021, Health and
- 8 Safety Code, is amended to read as follows:
- 9 (c) A physician shall examine the person as soon as possible
- 10 within 24 hours after the time the person is apprehended by the
- 11 peace officer or transported for emergency detention by the
- 12 person's guardian.
- SECTION 8. Subsection (a), Section 573.023, Health and
- 14 Safety Code, is amended to read as follows:
- 15 (a) A person apprehended by a peace officer or transported
- 16 <u>for emergency detention</u> under Subchapter A or detained under
- 17 Subchapter B shall be released on completion of the preliminary
- 18 examination unless the person is admitted to a facility under
- 19 Section 573.022.
- SECTION 9. Subsection (c), Section 573.024, Health and
- 21 Safety Code, is amended to read as follows:
- (c) If the person was apprehended by a peace officer under
- 23 Subchapter A, arrangements must be made to immediately transport
- 24 the person. If the person was <u>transported for emergency detention</u>
- 25 under Subchapter A or detained under Subchapter B, the person is
- 26 entitled to reasonably prompt transportation.
- 27 SECTION 10. Section 573.025, Health and Safety Code, is

- 1 amended to read as follows:
- 2 Sec. 573.025. RIGHTS OF PERSONS APPREHENDED, [OR] DETAINED,
- 3 OR TRANSPORTED FOR EMERGENCY DETENTION. (a) A person apprehended,
- 4 [or] detained, or transported for emergency detention under this
- 5 chapter has the right:
- 6 (1) to be advised of the location of detention, the
- 7 reasons for the detention, and the fact that the detention could
- 8 result in a longer period of involuntary commitment;
- 9 (2) to a reasonable opportunity to communicate with
- 10 and retain an attorney;
- 11 (3) to be transported to a location as provided by
- 12 Section 573.024 if the person is not admitted for emergency
- detention, unless the person is arrested or objects;
- 14 (4) to be released from a facility as provided by
- 15 Section 573.023;
- 16 (5) to be advised that communications with a mental
- 17 health professional may be used in proceedings for further
- 18 detention; and
- 19 (6) to be transported in accordance with Sections
- 20 573.026 and 574.045, if the person is detained under Section
- 21 573.022 or transported under an order of protective custody under
- 22 Section 574.023.
- 23 (b) A person apprehended, [or transported for
- 24 emergency detention under this subtitle shall be informed of the
- 25 rights provided by this section:
- 26 (1) orally in simple, nontechnical terms, within 24
- 27 hours after the time the person is admitted to a facility, and in

- 1 writing in the person's primary language if possible; or
- 2 (2) through the use of a means reasonably calculated
- 3 to communicate with a hearing or visually impaired person, if
- 4 applicable.
- 5 SECTION 11. Section 574.103, Health and Safety Code, is
- 6 amended to read as follows:
- 7 Sec. 574.103. ADMINISTRATION OF MEDICATION TO PATIENT UNDER
- 8 COURT-ORDERED MENTAL HEALTH SERVICES. (a) In this section, "ward"
- 9 has the meaning assigned by Section 601, Texas Probate Code.
- 10 <u>(b)</u> A person may not administer a psychoactive medication to
- 11 a patient who refuses to take the medication voluntarily unless:
- 12 (1) the patient is having a medication-related
- 13 emergency; [<del>or</del>]
- 14 (2) the patient is under an order issued under Section
- 15 574.106 authorizing the administration of the medication
- 16 regardless of the patient's refusal; or
- 17 (3) the patient is a ward who is 18 years of age or
- 18 older and the guardian of the person of the ward consents to the
- 19 administration of psychoactive medication regardless of the ward's
- 20 expressed preferences regarding treatment with psychoactive
- 21 medication.
- 22 SECTION 12. This Act takes effect September 1, 2003.
