- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 431, Health and Safety
- 6 Code, is amended by adding Section 431.009 to read as follows:
- 7 Sec. 431.009. APPLICABILITY OF CHAPTER TO FROZEN DESSERTS.
- 8 (a) This chapter applies to a frozen dessert, an imitation frozen
- 9 dessert, a product sold in semblance of a frozen dessert, or a mix
- 10 for one of those products subject to Chapter 440. A frozen dessert,
- an imitation frozen dessert, a product sold in semblance of a frozen
- dessert, or a mix for one of those products is food for purposes of
- this chapter.
- (b) Except as provided by Subsection (c), this chapter
- applies to the conduct of a person licensed under Chapter 440.
- (c) A person who holds a license under Chapter 440 related
- 17 to the manufacturing of a product regulated under that chapter and
- 18 is engaging in conduct within the scope of that license is not
- 19 required to hold a license as a food manufacturer or food wholesaler
- 20 under Subchapter J.
- 21 SECTION 2. Section 431.2211, Health and Safety Code, is
- 22 amended by adding Subsection (a-1) to read as follows:
- 23 (a-1) A person is not required to hold a license under this
- 24 subchapter if the person holds a license under Chapter 440 and is

- 1 engaging in conduct within the scope of that license.
- 2 SECTION 3. Subchapter A, Chapter 440, Health and Safety
- 3 Code, is amended by adding Section 440.007 to read as follows:
- 4 Sec. 440.007. APPLICABILITY OF OTHER LAW. Except as
- 5 provided by Section 431.009(c), Chapter 431 applies to a person or
- 6 product regulated under this chapter, including a frozen dessert
- 7 manufacturer, a frozen dessert, an imitation frozen dessert, a
- 8 product sold in semblance of a frozen dessert, and a mix for one of
- 9 those products.
- 10 SECTION 4. Subchapter B, Chapter 440, Health and Safety
- 11 Code, is amended by adding Section 440.017 to read as follows:
- 12 Sec. 440.017. REFUSAL TO GRANT LICENSE; SUSPENSION OR
- 13 REVOCATION OF LICENSE. In accordance with rules adopted under
- 14 Section 440.006, the commissioner may refuse an application for a
- 15 license under this chapter or may suspend or revoke a license issued
- 16 under this chapter.
- 17 SECTION 5. Section 440.031, Health and Safety Code, is
- amended by adding Subsection (c) to read as follows:
- 19 (c) The inspection procedures provided by this section are
- in addition to the procedures provided by Chapter 431.
- 21 SECTION 6. Subsection (c), Section 440.032, Health and
- 22 Safety Code, is amended to read as follows:
- (c) The penalty prescribed by this section is in addition to
- 24 any civil or administrative penalty or sanction otherwise imposed
- 25 under Chapter 431 or other [by] law.
- SECTION 7. This Act takes effect September 1, 2003.
