9	Sec. 327.001. DEFINITIONS. In this chapter:
10	(1) "County" means the county that created the zoo
11	board.
12	(2) "Director" means a zoo board member.
13	(3) "Zoo board" means a zoological operation and
14	maintenance board created under this chapter.

16	SUBCHAPTER B. CREATION OF ZOO BOARD
17	Sec. 327.051. COUNTIES AUTHORIZED TO CREATE ZOO BOARD. The
18	commissioners court of a county with a population of more than 1.5
19	million that is adjacent to a county with a population of more than
20	one million by order may authorize the creation of a zoo board under
21	this chapter to establish, finance, and manage facilities and
22	services to provide conservation, education, research, public
23	recreation, and care relating to the study and display of animals

and other specimens in a public zoological park.

1	Sec. 327.052. ORDER CREATING ZOO BOARD. (a) The order
2	authorizing the creation of a zoo board must specify that the zoo
3	board:
4	(1) is being created under this chapter; and
5	(2) has the powers and duties provided in this
6	chapter.
7	(b) The order authorizing the creation of the zoo board may
8	also serve as the election order under Section 327.054.
9	Sec. 327.053. AUTHORITY TO TAX; ELECTION REQUIRED. The
10	county may assess and collect a separate ad valorem tax to provide
11	revenue for a zoo board that it has created. The tax may not exceed
12	a rate of three cents per \$100 valuation of taxable property, and
13	the amount of the tax must be approved by a majority of the voters of
14	the county voting at an election held for that purpose by the
15	county.
16	Sec. 327.054. ELECTION ORDER. (a) An order for an election
17	under Section 327.053 must state:
18	(1) the nature of the election, including the
19	proposition that is to appear on the ballot;

Sec. 327.101. BOARD OF DIRECTORS. (a) A zoo board consists

- 10 necessary legal services for the zoo board.
- Sec. 327.162. SUPERVISION BY COUNTY. (a) The county

- 25 under Section 327.162 and subject to the approval of the county
- commissioners court of a budget under Section 327.207.
- Sec. 327.202. ACCOUNTING AND CONTROL PROCEDURES. A zoo

- 1 board by rule may adopt accounting and control procedures for the
- 2 zoo board, subject to the supervision of the county commissioners
- 3 court under Section 327.162.
- 4 Sec. 327.203. PURCHASING AND EXPENDITURE METHOD. A zoo
- 5 board by rule may prescribe the zoo board's method of making
- 6 purchases and expenditures.
- 7 Sec. 327.204. FISCAL YEAR. (a) A zoo board by rule shall
- 8 establish the zoo board's fiscal year.
- 9 (b) The zoo board may not change the fiscal year more than
- once in a two-year period.
- Sec. 327.205. ANNUAL AUDIT REQUIRED. A zoo board shall have
- 12 an annual audit of the zoo board's financial condition performed by
- 13 an independent auditor.
- 14 Sec. 327.206. ANNUAL BUDGET PROPOSAL. (a) A zoo board
- shall propose an annual budget.
- 16 (b) The proposed budget must contain a complete financial
- 17 statement, including the:
- 18 <u>(1) outstanding zoo board obligations;</u>
- 19 (2) amount of cash on hand to the credit of each zoo
- 20 board fund;
- 21 (3) amount of money received by the zoo board from all
- 22 sources during the previous year;
- 23 (4) estimated amount of money available to the zoo
- 24 board from all sources during the current fiscal year;
- 25 (5) amount of money needed to fund programs approved

- 4 Sec. 327.207. ADOPTION OF ANNUAL BUDGET; HEARINGS. (a) Not
- 5 later than the 100th day before the date each fiscal year begins,
- 6 the zoo board shall hold a public hearing on the proposed annual
- 7 budget.
- 8 (b) The zoo board shall publish notice of the hearing in a
- 9 newspaper with general circulation in the county not later than the
- 10 10th day before the date of the hearing.
- 11 (c) Any county resident is entitled to be present and
- 12 participate at the hearing.
- 13 (d) Not later than the 80th day before the date each fiscal
- 14 year begins, the zoo board shall adopt a budget. The zoo board may

11	(B) any other governmental entity for property

14	Sec. 327.302. TAX RATE. In adopting the tax rate, the
15	county may consider the zoo board's income from sources other than
16	taxation.

18	SUBCHAPTER H. DISSOLUTION
19	Sec. 327.351. DISSOLUTION BY COUNTY. (a) The county
20	commissioners court may dissolve the zoo board if all zoo board
21	debts and obligations have been discharged.
22	(b) Any property remaining after dissolution is transferred
23	to the county.
24	SECTION 2. This Act takes effect immediately if it receives
25	a vote of two-thirds of all the members elected to each house, as
26	provided by Section 39, Article III, Texas Constitution. If this
27	Act does not receive the vote necessary for immediate effect, this
