- 4 (2) in a form prescribed by the board.
- 5 (d) The superintendent or director shall notify the board of
  6 trustees or governing body of the school district, regional
  7 education service center, or shared services arrangement and the
  8 educator of the filing of the report required by Subsection (c).
- 9 (e) A superintendent or director who in good faith and while
  10 acting in an official capacity files a report with the State Board
  11 for Educator Certification under this section is immune from civil
  12 or criminal liability that might otherwise be incurred or imposed.
  - (f) The State Board for Educator Certification shall determine whether to impose sanctions against a superintendent or director who fails to file a report in violation of Subsection (c).
- 16 <u>(g) The State Board for Educator Certification shall</u> 17 propose rules as necessary to implement this section.
- SECTION 3. Subsection (d), Section 261.105, Family Code, is amended to read as follows:
  - (d) If the department initiates an investigation and determines that the abuse or neglect does not involve a person responsible for the child's care, custody, or welfare, the department shall refer the report to a law enforcement agency for further investigation. If the department determines that the abuse or neglect involves an employee of a public primary or secondary school, and that the child is a student at the school, the department shall orally notify the superintendent of the school

- 2 SECTION 4. This Act applies beginning with the 2003-2004
- 3 school year.
- 4 SECTION 5. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2003.
