AN ACT

2 relating to the composition of certain districts of the Texas
3 Senate.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE I

6 SECTION 1. The composition of Texas Senate Districts 9 and
7 10 as enacted in 2001 by the Legislative Redistricting Board is
8 superseded by Article II of this Act.

17 ARTICLE III

18 SECTION 1. In this Act, "tract" and "block" mean the
19 geographic areas identified by those terms on the 2000 Census
20 TIGER/Line File, prepared by the federal Bureau of the Census for
21 the Twenty-second Decennial Census of the United States, enumerated
22 as of April 1, 2000.

23 SECTION 2. It is the intention of the Texas Legislature
24 that, if any county, tract, block, or other geographic area has
25 erroneously been left out of this Act, a court reviewing this Act
26 should include that area in the appropriate district in accordance
27 with the intent of the legislature, using any available evidence of

1 that intent, including evidence such as that used by the Supreme
2 Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W. 749
3 (1922).

4 SECTION 3. The districts set out in Article II of this Act
5 apply to the election of the members for those districts of the
6 Texas Senate beginning with the primary and general elections in
7 2004 for members of the 79th Legislature. This Act does not affect
8 the membership or districts of the Texas Senate of the 78th
9 Legislature.

10 SECTION 4. This Act takes effect immediately if it receives
11 a vote of two-thirds of all the members elected to each house, as
12 provided by Section 39, Article III, Texas Constitution. If this
13 Act does not receive the vote necessary for immediate effect, this
14 Act takes effect September 1, 2003.
