4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 9.516, Business & Commerce Code, is
6	amended to read as follows:
7	Sec. 9.516. WHAT CONSTITUTES FILING; EFFECTIVENESS OF
8	FILING. (a) Except as otherwise provided in Subsection (b),
9	communication of a record to a filing office and tender of the
10	filing fee or acceptance of the record by the filing office
11	constitutes filing.
12	(b) Filing does not occur with respect to a record that a
13	filing office refuses to accept because:
14	(1) the record is not on the National Standard Form or
15	a form approved by the International Association of Commercial
16	Administrators (IACA) and adopted by administrative rule by the
17	secretary of state;
18	(2) the record is not communicated by a method or
19	medium of communication authorized by the filing office;
20	(3) [(2)] an amount equal to or greater than the
21	applicable filing fee is not tendered;
22	(4) [(3)] the filing office is unable to index the
23	record because:
24	(A) in the case of an initial financing

statement, the record does not provide a name for the debtor; 1 2 (B) in the case of an amendment or correction 3 statement, the record: 4 (i) does not identify the initial financing statement as required by Section 9.512 or 9.518, as applicable; or 5 (ii) identifies initial 6 an financing 7 statement whose effectiveness has lapsed under Section 9.515; in the case of an initial financing statement 8 (C) 9 that provides the name of a debtor identified as an individual or an 10 amendment that provides a name of a debtor identified as an 11 individual that was not previously provided in the financing statement to which the record relates, the record does not identify 12 the debtor's last name; or 13 in the case of a record filed or recorded in 14 (D) the filing office described in Section 9.501(a)(1), the record does 15 not provide a sufficient description of the real property to which 16 17 it relates; (5) [<del>(4)</del>] in the case of an initial financing 18 statement or an amendment that adds a secured party of record, the 19 20 record does not provide a name and mailing address for the secured party of record; 21 initial 22 (6) [(5)] in of an the case financing statement or an amendment that provides a name of a debtor that was 23 not previously provided in the financing statement to which the 24 25 amendment relates, the record does not: provide a mailing address for the debtor; 26 (A) 27 (B) indicate whether the debtor is an individual

1 or an organization; or

2 (C) if the financing statement indicates that the
3 debtor is an organization, provide:

4 (i) a type of organization for the debtor;
5 (ii) a jurisdiction of organization for the
6 debtor; or

7 (iii) an organizational identification
8 number for the debtor or indicate that the debtor has none;

9 <u>(7)</u> [<del>(6)</del>] in the case of an assignment reflected in an 10 initial financing statement under Section 9.514(a) or an amendment 11 filed under Section 9.514(b), the record does not provide a name and 12 mailing address for the assignee; or

13 <u>(8)</u> [<del>(7)</del>] in the case of a continuation statement, the 14 record is not filed within the six-month period prescribed by 15 Section 9.515(d).

(c) For purposes of Subsection (b):

17 (1) a record does not provide information if the18 filing office is unable to read or decipher the information; and

19 (2) a record that does not indicate that it is an 20 amendment or identify an initial financing statement to which it 21 relates, as required by Section 9.512, 9.514, or 9.518, is an 22 initial financing statement.

(d) A record that is communicated to the filing office with tender of the filing fee, but that the filing office refuses to accept for a reason other than one set forth in Subsection (b), is effective as a filed record except as against a purchaser of the collateral that gives value in reasonable reliance upon the absence

1 of the record from the files.

2 SECTION 2. Section 9.521, Business & Commerce Code, is 3 amended to read as follows:

Sec. 9.521. UNIFORM FORM OF WRITTEN FINANCING STATEMENT AND 4 5 AMENDMENT. (a) A filing office that accepts written records may 6 not refuse to accept a written initial financing statement on the 7 National Standard Form or a form approved by the International Association of Commercial Administrators (IACA) and adopted by 8 9 administrative rule by the secretary of state, [in the following form and format] except for a reason set forth in Section 10 11 9.516(b).[+

(b) A filing office that accepts written records may not refuse to accept a written record <u>on the National Standard Form or a</u> <u>form approved by the International Association of Commercial</u> <u>Administrators (IACA) and adopted by administrative rule by the</u> <u>secretary of state, [in the following form and format]</u> except for a reason set forth in Section 9.516(b).[+
