6	license of a person licensed under this chapter who is <u>:</u>
7	(1) charged with a felony and [is] placed on community
8	supervision <u>,</u> regardless of whether the court defers further
9	proceedings without entering an adjudication of guilt <u>; or</u>
10	(2) charged with an offense listed in Section 13B(b),
11	Article 42.12, Code of Criminal Procedure, and placed on community
12	supervision, regardless of whether the court defers further
13	proceedings without entering an adjucation of guilt, if the victim
14	of the offense is described by Section 13B(a), Article 42.12, Code
