A reinstatement of the exemption must be 14 approved in the same manner. (f) The governing board of a taxing entity created before 15 1980 in which the principal municipality has a population of less 16 17 than 1.2 million may not repeal the application of the exemption provided by Subsection (a) unless the repeal is first approved by a 18 majority vote of a committee created under Section 451.061(d), 19 Transportation Code. A reinstatement of the exemption must be 20 approved in the same manner. 21
