(a) Not 11 12 later than the first anniversary of the date of the cancellation of the public use for which real property was acquired through eminent 13 14 domain, the governmental entity shall make a diligent effort to discover each property owner, or the heirs of the property owner if 15 the property owner is deceased, who owned the real property 16 interest immediately before the governmental entity acquired the 17 property interest. 18 (b) The governmental entity shall personally deliver or 19 send by certified mail, return receipt requested, to each property 20 21 owner identified under Subsection (a) a notice containing: 22 (1) an identification, which is not required to be a 23 legal description, of the property that was acquired; (2) an identification of the public use for which the 24

2	been canceled; and
3	(3) a description of the property owner's right under
4	this subchapter to repurchase the property.
5	Sec. 21.103. RESALE OF PROPERTY; PRICE. Not later than the
6	first anniversary of the date on which a person receives notice
7	under Section 21.102, or sooner on request of the person, the
8	governmental entity shall offer to sell the property interest to
9	that person, or the person's heirs if the person is deceased. The
10	sale price, if the person accepts the offer, must be the lesser of:
11	(1) fair market value of the property interest; or
12	(2) the purchase price paid to the owner by the
13	governmental entity when the governmental entity acquired the
14	interest by eminent domain.

SECTION 2. (a) Subchapter E, Chapter 21, Property Code, as added by this Act, applies only to a real property interest acquired by a governmental entity on or after January 1, 1980.

(b) For real property that was acquired before the effective date of this Act through eminent domain for a public use and for which the public use was canceled before the effective date of this Act, the one-year period described by Section 21.102, Property Code, as added by this Act, shall be computed as if the date of cancellation were the effective date of this Act.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
