| 7  | SUBCHAPTER B. APPEALS PROCESS FOR DEPUTY CONSTABLES                |
| 8  | IN CERTAIN COUNTIES  |
| 9  | Sec. 160.051. DEFINITION. In this subchapter, "termination         |
| 10 | or suspension" means the revocation of a deputy constable's        |
| 11 | appointment or the temporary, indefinite, or permanent suspension  |
| 12 | of a deputy constable from duty.                                   |
| 13 | Sec. 160.052. COUNTIES AND DEPUTY CONSTABLES AFFECTED.             |
| 14 | This subchapter applies only to the termination or suspension of a |
| 15 | deputy constable in a county with a population of more than three  |
| 16 | million.   |
| 17 | Sec. 160.053. TERMINATION OR SUSPENSION. (a) A deputy              |
| 18 | constable may be terminated or suspended only for inadequate       |
| 19 | performance or a violation of workplace rules.                     |
| 20 | (b) A constable must notify a deputy constable in writing of       |
| 21 | a termination or suspension. The notification must specifically    |
| 22 | identify the incident that is the cause for the termination or     |
| 23 | suspension.  |
| 24 | (c) A deputy constable may not be terminated or suspended          |

| 5  | Sec. 160.054. APPEALS COMMISSION. (a) The constables of a           |
| 6  | county by collective agreement shall annually appoint three persons |
| 7  | to serve as members of the appeals commission.                      |
| 8  | (b) A member of the appeals commission is not personally            |
| 9  | liable for damages resulting from a decision of the appeals         |
| 10 | commission.   |
| 11 | (c) A member of the appeals commission may not be employed          |
| 12 | by the county.  |
| 13 | (d) The constables of the county collectively shall provide         |
| 14 | the facilities and support staff necessary for the operation of the |
| 15 | appeals commission.   |
| 16 | Sec. 160.055. RULES OF PROCEDURE. The appeals commission            |
| 17 | shall adopt, publish, and enforce rules regarding the procedure for |
| 18 | an appeal under this subchapter.                                    |
| 19 | Sec. 160.056. APPEAL OF TERMINATION OR SUSPENSION.                  |
| 20 | (a) Not later than the fifth day after the date a deputy constable  |
| 21 | receives written notification of termination or suspension of       |
| 22 | employment, the deputy constable may appeal a termination or        |
| 23 | suspension by:  |
| 24 | (1) filing a written appeal with the constable; or                  |
| 25 | (2) directly filing a written appeal with or appearing              |

| 27 | (b) Not later than the fifth day after the date a deputy            |

No. 1733 constable receives written notification of a constable's decision 1 on appeal under Subsection (a)(1), the deputy constable may appeal 2 3 the constable's decision to the appeals commission by filing a written appeal with or appearing in person before the appeals 4 5 commission. 6 (c) The appeals commission shall make a just and fair 7 decision in writing not later than the 30th day after the date the 8 deputy constable receives written notification of termination or suspension or receives written notification of a constable's 9 decision under Subsection (a)(1), as applicable. 10 (d) In its decision, the appeals commission may: 11 (1) affirm the termination or suspension of the deputy 12 13 constable for cause; (2) grant the relief requested by the deputy constable 14 and reinstate the deputy constable to the job assignment held 15 16 before the termination or suspension without loss of compensation or benefits, including back pay and benefits; or 17 18 (3) modify the constable's disciplinary action from which the appeal is taken. 19 (e) A decision of the appeals commission is final and 20 binding and may not be appealed. This subsection does not affect a 21 22 deputy constable's right to contest a termination or suspension in another forum under federal law. 23 (f) A deputy constable may not appeal any other personnel 24 action under this subchapter, including a written reprimand, 25 transfer, promotion, or demotion. 26 Sec. 160.057. EXEMPTIONS. A constable may designate as 27

## exempt from the application of this subchapter not more than eight deputy constables.

3 SECTION 2. Sections 160.001 through 160.007, Local
4 Government Code, are redesignated as Subchapter A, Chapter 160,
5 Local Government Code, and amended to read as follows:

## SUBCHAPTER A. GRIEVANCE PROCEDURE FOR CERTAIN COUNTIES

Sec. 160.001. POLICY. The purpose of this <u>subchapter</u>
[chapter] is to provide reasonable, standardized grievance
procedures for certain counties and their employees because:

it is the policy of this state that the right of 10 (1)11 public employees to present, individually or through а representative that does not claim the right to strike, grievances 12 13 concerning their wages, hours of work, or conditions of work should 14 continue unimpaired; and

15 (2) the application of that policy creates a need for
16 reasonable, standardized procedures for certain populous counties
17 and their employees.

Sec. 160.002. COUNTIES AND 18 EMPLOYEES AFFECTED. This subchapter [chapter] applies only to a county with a population of 19 more than 2.4 million and its employees, including but not limited 20 to the employees of road and bridge districts, flood control 21 22 districts, adult probation departments, and juvenile probation departments in the county. However, this subchapter [chapter] does 23 not apply to the employees of a sheriff's department. 24

25 Sec. 160.003. DEFINITION. In this <u>subchapter</u> [<del>chapter</del>], 26 "grievance" means a claim by an employee that the employee was 27 adversely affected by a violation, misinterpretation,

1 misapplication, or disparity in the application of a specific law, 2 ordinance, resolution, written or unwritten policy, or rule 3 regarding wages, hours of work, or conditions of work.

Sec. 160.004. PROCEDURE IN GENERAL. A grievance must be
presented and adjusted in accordance with the grievance procedures
prescribed by this <u>subchapter</u> [chapter].

Sec. 160.005. STANDARDIZED GRIEVANCE PROCEDURE. (a) The commissioners court of the county shall enact orders to provide for:

(1) filing of written grievances;

11 (2) written responses to the grievance allegations;

12 (3) procedures for appeal to an appointed county 13 grievance resolutions committee;

14

(4) further appeal to the commissioners court;

15 (5) presentation of grievances by an employee's 16 requested representative;

17 (6) reasonable leave with pay for the presentation of18 grievances; and

19 (7) other necessary procedures to permit effective
 20 implementation of this <u>subchapter</u> [chapter].

(b) The orders and procedures shall apply equally to all employees of the county, including employees of independent elected officials, and shall provide for reasonable timetables for filing and responding to grievances.

25 Sec. 160.006. NO RETALIATION OR REPRISAL. (a) An employee 26 may not be made subject to retaliation, reprisal, or discrimination 27 on account of having exercised any right or participated in any

procedure established by this <u>subchapter</u> [chapter]. A supervisor or management official may not be made subject to retaliation, reprisal, or discrimination because of any grievance adjustment offered under this <u>subchapter</u> [chapter] to an employee with a grievance or because of testifying on any employee's behalf during a grievance procedure under this subchapter [chapter].

7 (b) A district court of appropriate venue may enjoin a 8 violation of this section. The court may order, in addition to 9 other relief, the mandatory reinstatement and the payment of back 10 pay for individuals discharged, suspended, or demoted in violation 11 of this section.

(c) An individual suffering retaliation, reprisal, or discrimination in violation of this section is entitled to reasonable attorney's fees as a result of successful court action regarding the retaliation, reprisal, or discrimination.

16 Sec. 160.007. PROSPECTIVE APPLICATION OF <u>SUBCHAPTER</u> 17 [CHAPTER] AND AMENDED ORDER. (a) This <u>subchapter</u> [Act] applies 18 only to a grievance based on events that occur on or after June 20, 19 1987.

(b) If the commissioners court amends an order adopted under this <u>subchapter</u> [chapter], the amended order does not apply to a grievance alleged to have occurred before the date of the amended order.

SECTION 3. (a) The change in law made by Subchapter B, Chapter 160, Local Government Code, as added by this Act, applies only to a deputy constable who is terminated or suspended from duty on or after the effective date of this Act.

1 (b) A deputy constable who is terminated or suspended from 2 duty before the effective date of this Act is covered by the law in 3 effect when the deputy constable was terminated or suspended, and 4 the former law is continued in effect for that purpose.

5 SECTION 4. This Act takes effect September 1, 2003.
