## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the conditional grant program administered by the Texas
- 3 Department of Transportation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subdivision (4), Section 56.141, Education Code,
- 6 is amended to read as follows:
- 7 (4) "Eligible profession" means the profession of
- 8 engineering or another profession <u>as defined</u> [identified] by [the]
- 9 department rule for which the department determines there is a need
- 10 [as having a significant statistical underrepresentation of
- 11 minorities or women] in the department's workforce.
- 12 SECTION 2. Subsection (a), Section 56.142, Education Code,
- is amended to read as follows:
- 14 (a) The department shall establish and administer a
- 15 conditional grant program under this subchapter to provide
- 16 financial assistance to eligible [women and minority] students who
- 17 agree to work for the department in an eligible profession for the
- 18 two academic years immediately following the date of the student's
- 19 receipt of an eligible degree.
- SECTION 3. Section 56.143, Education Code, is amended to
- 21 read as follows:
- Sec. 56.143. ELIGIBLE STUDENT. (a) To be eligible for a
- 23 conditional grant under this subchapter, a student must:
- 24 (1) complete and file with the department, on forms

- 1 prescribed by the department, a conditional grant application and a
- 2 declaration of intent to become a member of an eligible profession
- 3 and work for the department for the two academic years immediately
- 4 following the date of the student's receipt of an eligible degree;
- 5 (2) enroll in an institution;
- 6 (3) be a Texas resident, as defined by Texas Higher
- 7 Education Coordinating Board rule;
- 8 (4) be <u>economically disadvantaged</u> [ $\frac{a \text{ minority}}{a}$ ], as
- 9 defined by department rule[, or a woman]; and
- 10 (5) have complied with any other requirements adopted
- 11 by the department under this subchapter.
- 12 (b) In determining who should receive a grant under this
- 13 program, the department:
- (1) shall give highest priority to students who
- demonstrate the greatest financial need; and
- 16 (2) may consider whether the applicant would be the
- first generation of the applicant's family to attend or graduate
- 18 from an undergraduate program or from a graduate or professional
- 19 program.
- SECTION 4. Section 56.147, Education Code, is amended by
- reenacting and amending Subsection (b), as amended by Chapters 151
- 22 and 165, Acts of the 74th Legislature, Regular Session, 1995, and by
- 23 adding Subsection (c) to read as follows:
- 24 (b) The department shall issue not less than \$400,000
- 25 annually in conditional grants under this subchapter from money
- 26 available to fund the conditional grant program [gifts, grants, and
- 27 <u>funds described by Subsection (a)</u>].

- (c) The department may provide outreach programs to recruit students into the conditional grant program.
- 3 SECTION 5. (a) This Act takes effect September 1, 2003.

(b) The change in law made by this Act does not affect the eligibility of a person awarded a grant under Subchapter I, Chapter 56, Education Code, before the effective date of this Act to receive the grant or to participate in the conditional grant program under Subchapter I, Chapter 56, Education Code, as that subchapter existed when the person was awarded the grant, and the former law is continued in effect for that person.
