SECTION 5. (a) This Act takes effect September 1, 2003.

(b) The change in law made by this Act does not affect the eligibility of a person awarded a grant under Subchapter I, Chapter 56, Education Code, before the effective date of this Act to receive the grant or to participate in the conditional grant program under Subchapter I, Chapter 56, Education Code, as that subchapter
